That in consideration of **Two Hundred Sixty Thousand and 00/100 Dollars (\$260,000)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Richard C. Mason and Gina Mason

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 4, according to the Survey of Meadow Brook Cluster Homes, 2nd Sector, as recorded in Map Book 22, Page 110, in the Probate Office of Shelby County, Alabama.



\$247,000 of the proceeds come from a mortgage recorded simultaneously herewith.

(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.
