(hereinafter referred to as "Grantor") does grant, bargain, sell and convey unto

**Tilwana Conwell**

(hereinafter referred to as "Grantee") the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 130, according to the Final Plat of Shiloh Creek, Sector One, Plat II, as recorded in Map Book 42, Page 43, in the Probate Office of Shelby County, Alabama.**

\$100,613.15 of the proceeds come from a mortgage recorded simultaneously herewith.


TO HAVE AND TO HOLD unto Grantee, her heirs and assigns, forever.
