KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of July, 2011, Michael Lynn Laster, an unmarried man and Adrian Carleen Lucas, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for First Federal Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20110727000218400, said mortgage having subsequently been transferred and assigned to JPMorgan Chase Bank, N.A., by instrument recorded in Instrument Number 20120817000305120, in the aforesaid Probate Office ("Transferee"); and

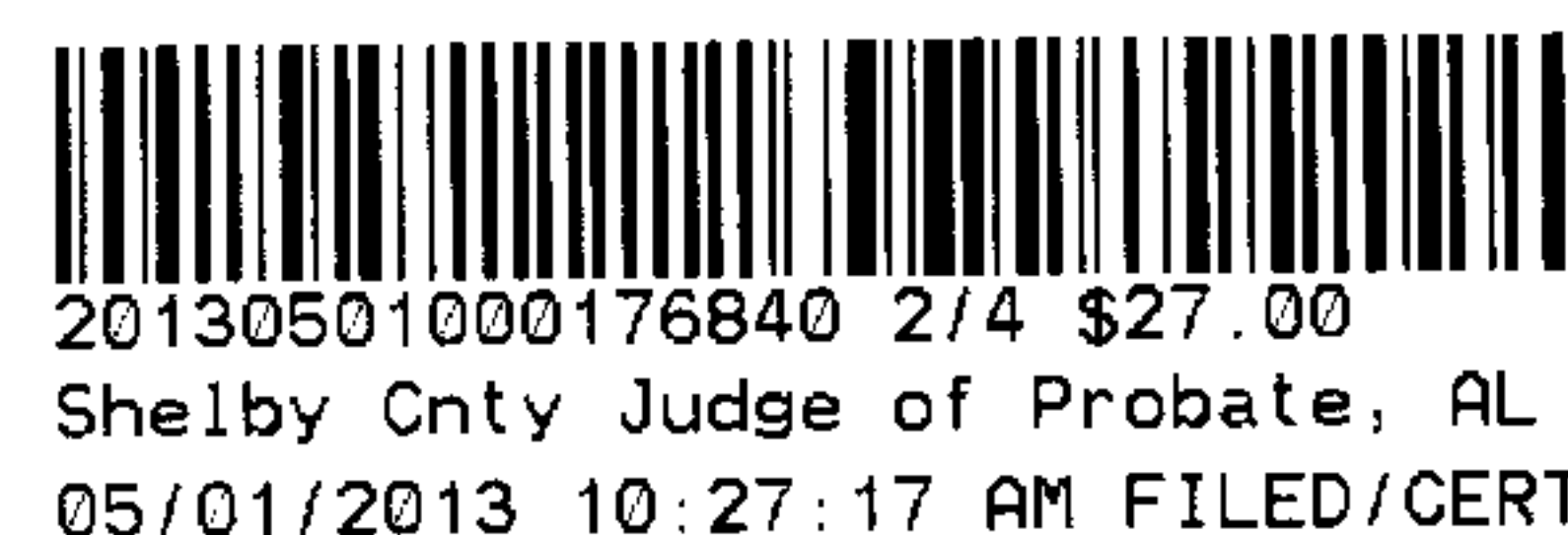
