KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of March, 2007, Christopher R. Shadrick and Olia Lazareva aka Olga Shadrick, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Choice Capital Funding, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070402000148270, said mortgage having subsequently been transferred and assigned to Deutsche Bank Trust Company Americas as Trustee for RALI 2007-QA4 , by instrument recorded in Instrument Number 20120727000271760, in the aforesaid Probate Office ("Transferee"); and

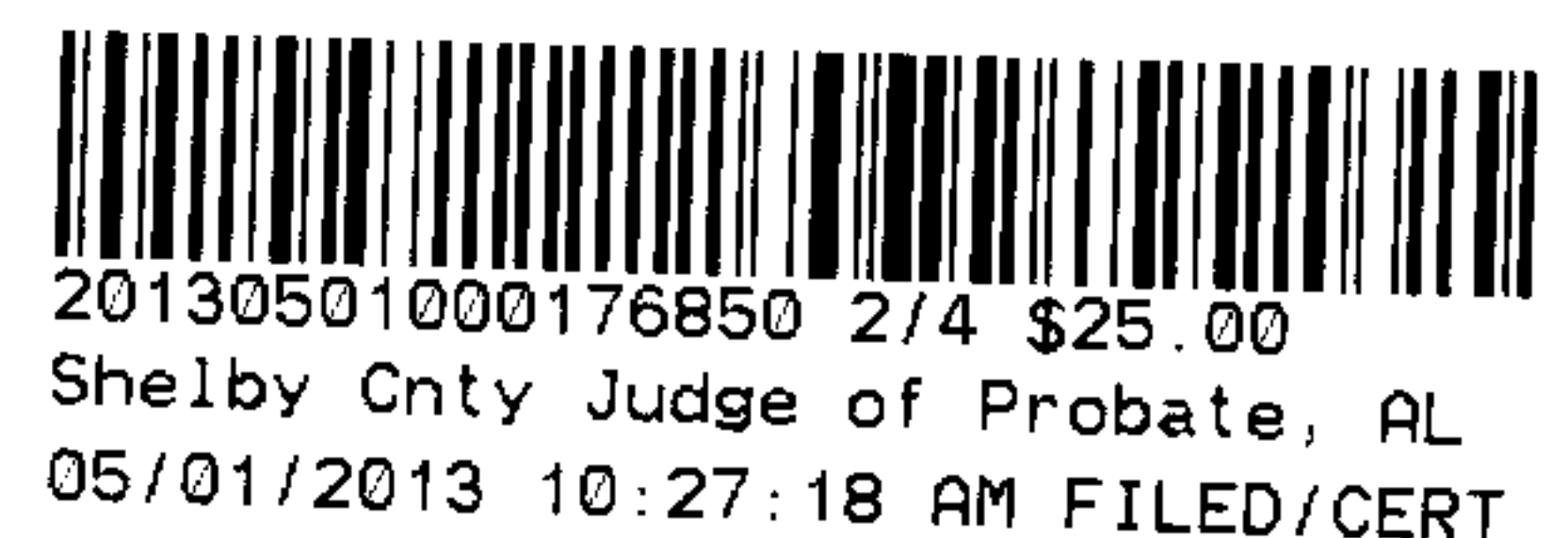
