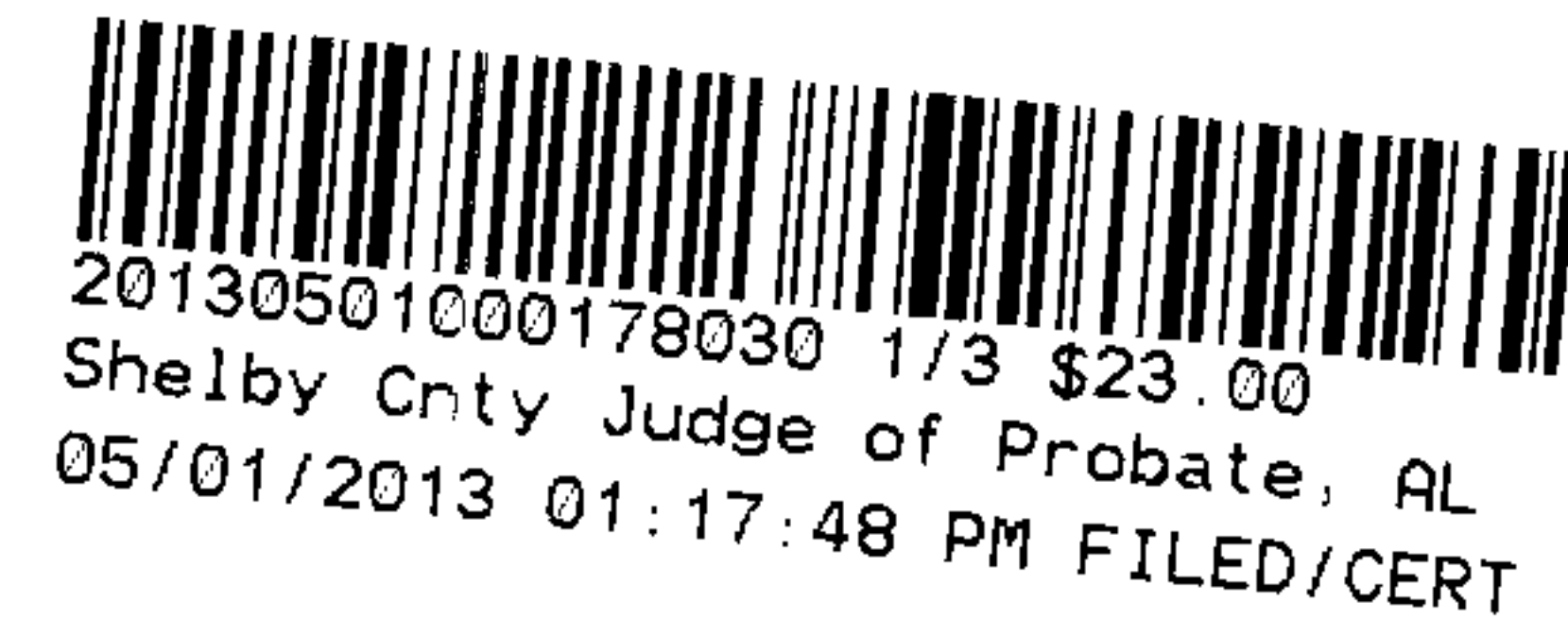

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on January 11, 2008, **Edward Cingoranelli And Stacey L Cingoranelli, husband and wife, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Henger Rast Mortgage Corporation its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20080116000022580, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to Nationstar Mortgage LLC, in Instrument No. 20130111000015620; and
