
**CORRECTIVE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 16th day of September, 2005, Andrea M Ramp, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20050926000498270, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage, LLC ("Transferee"), by instrument executed on December 10, 2012 and recorded on January 3, 2013 as Instrument Number 20130103000004530, in the aforesaid Probate Office; and


WHEREAS, David Sigler was the auctioneer and the person conducting the sale for said Nationstar Mortgage, LLC; and
