KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of December, 2011, Angelia Harris-Brown an unmarried person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Gateway Mortgage Group, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120105000005330, said mortgage having subsequently been transferred and assigned to Gateway Mortgage Group, LLC, by instrument recorded in Instrument Number 20130306000093270, in the aforesaid Probate Office ("Transferee"); and

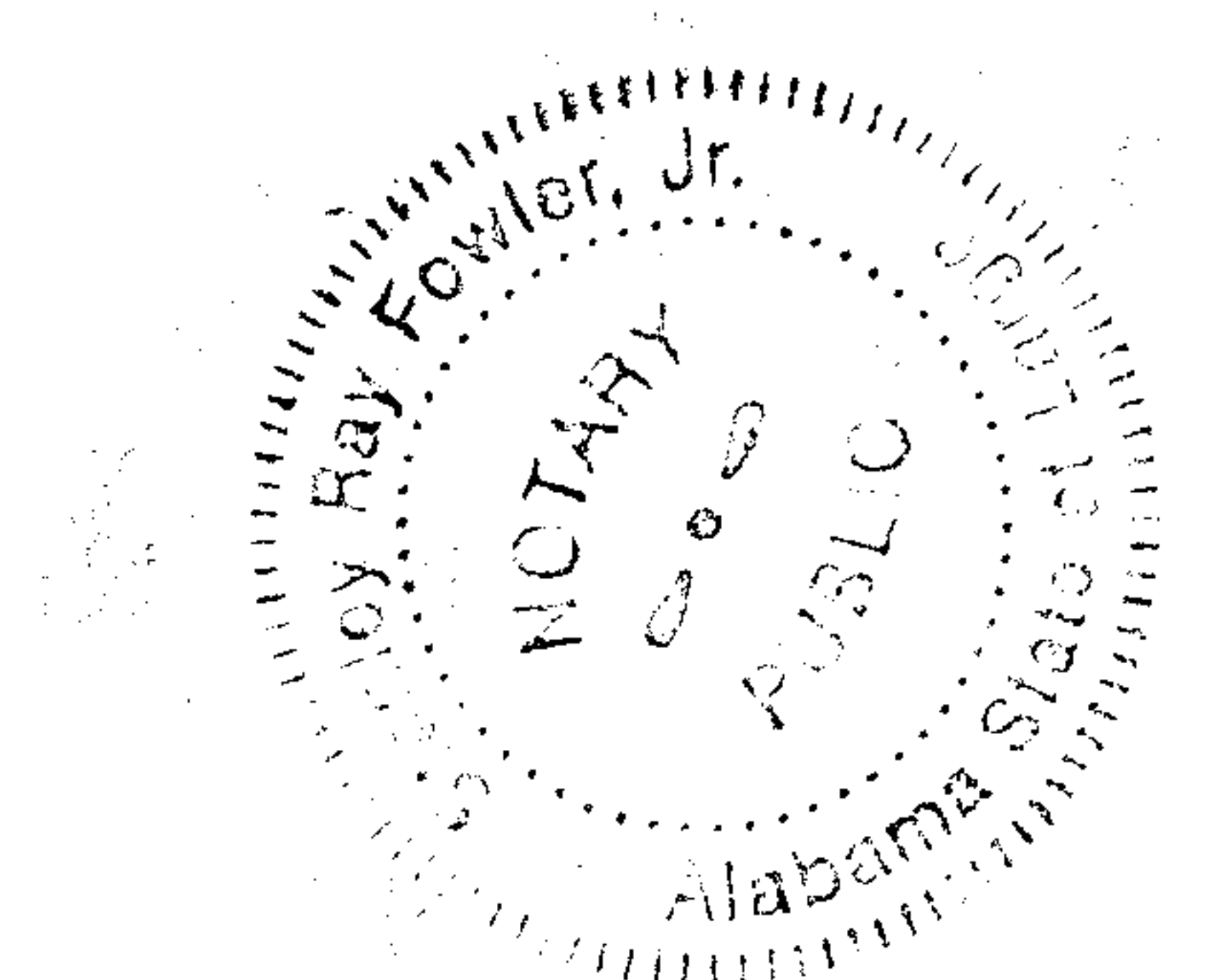
