KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of March, 2007, Kimberly G. Yancy, an unmarried person and Rebecca J. 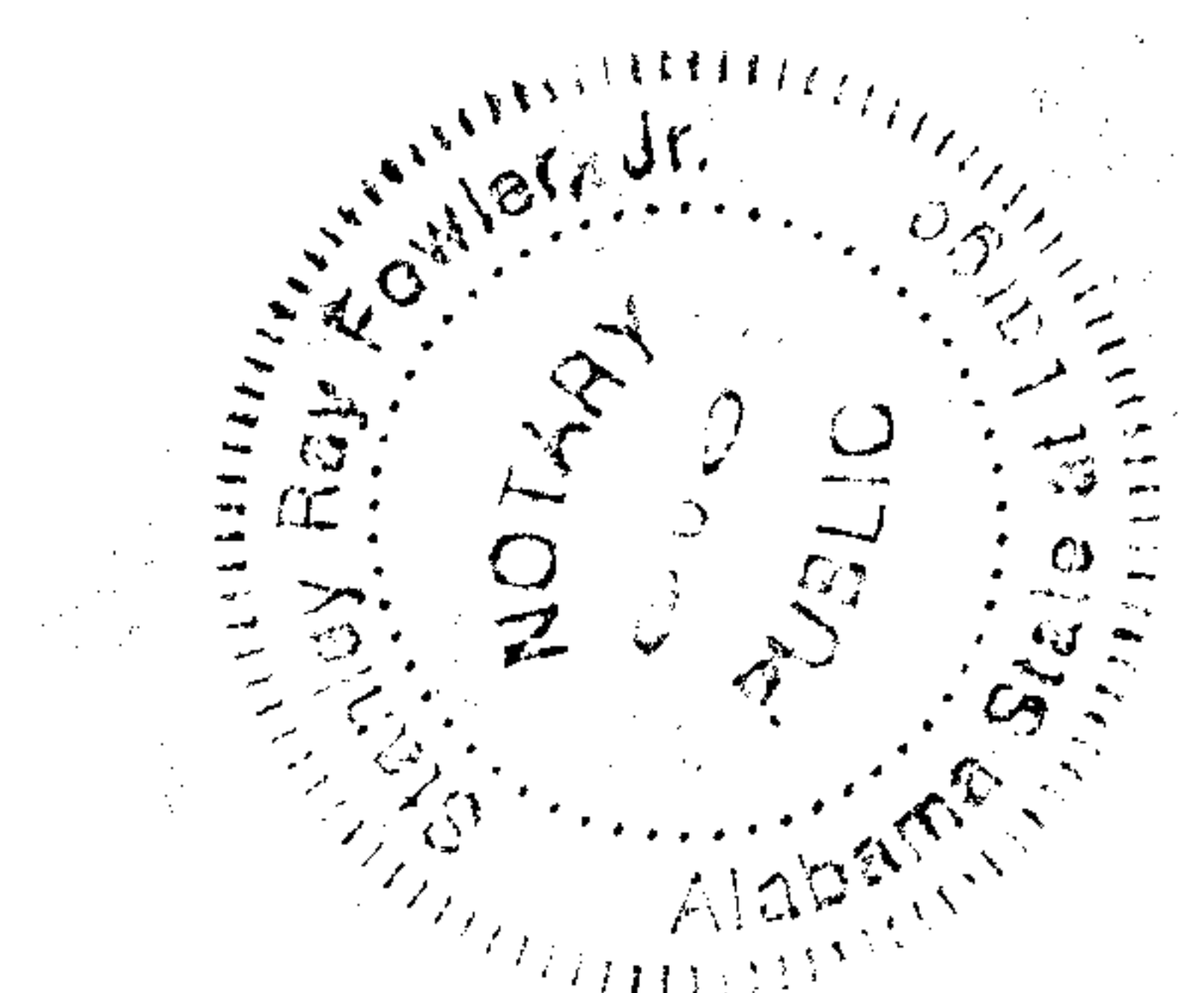
