KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of December, 2007, Paul Cedolphus Jones, a single person and Shelley Lee McCollum, a single person, executed that certain mortgage on real property hereinafter described to Elite Home Mortgage, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080107000006720, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A. successor by merger to Wells Fargo Home Mortgage, Inc., by instrument recorded in Instrument Number 20080903000350440, in the aforesaid Probate Office ("Transferee"); and

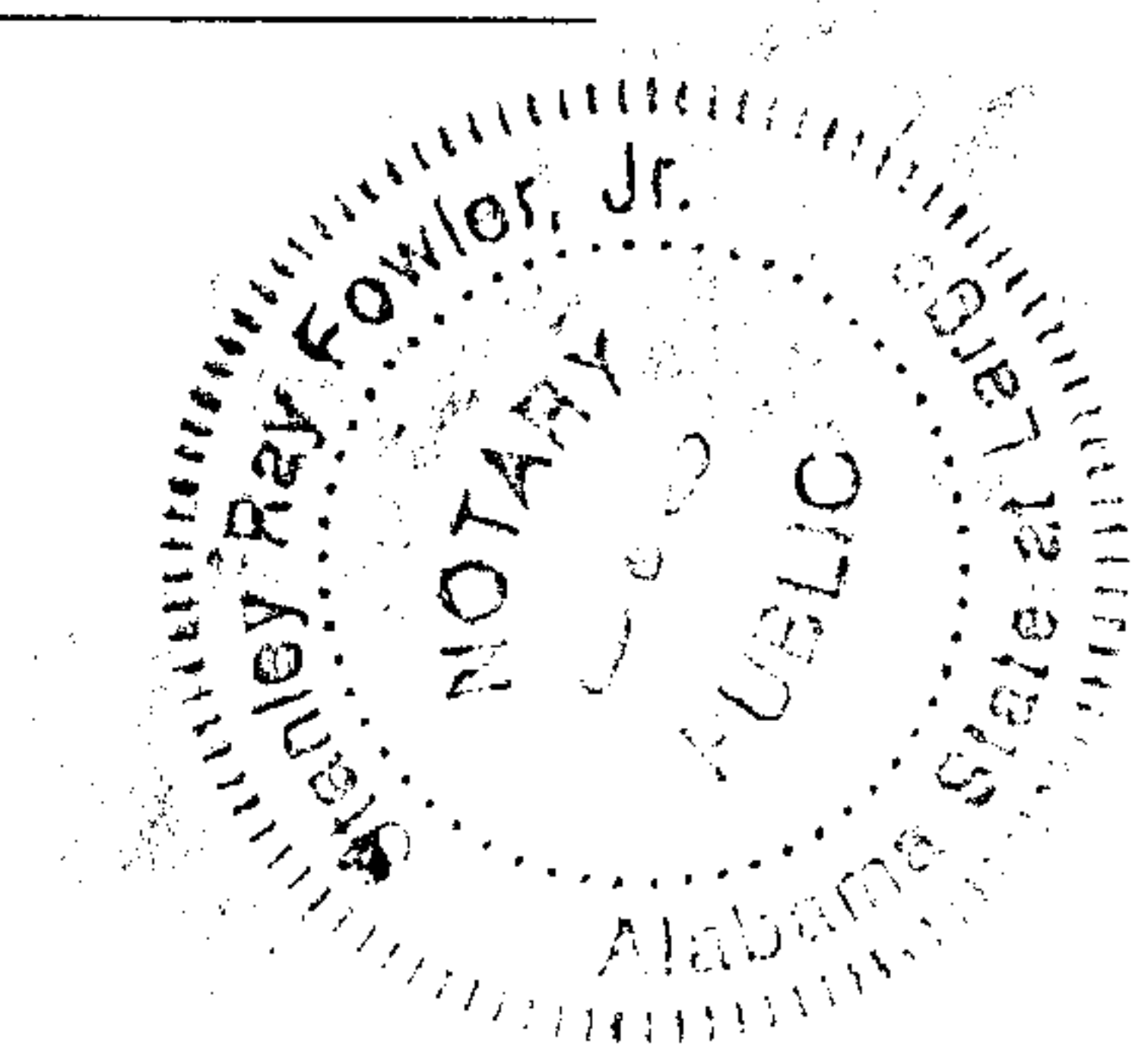

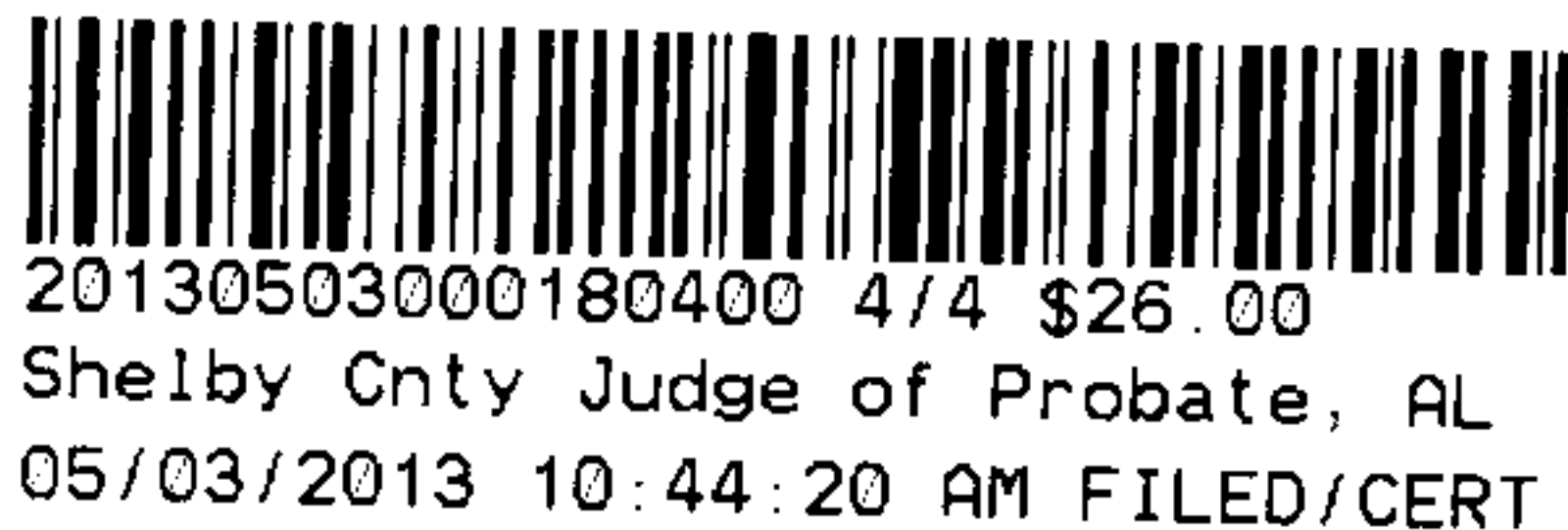
