## WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

STATE OF ALABAMA COUNTY OF SHELBY

### KNOW ALL MEN BY THESE PRESENTS,

On this May 9, 2013, That for and in consideration of ONE HUNDRED FORTY NINE THOUSAND FIVE HUNDRED AND N0/100 (\$149,500.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned MICHAEL KENNEDY and APRIL KENNEDY, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, JUAN REYES CASIMIRO and LEONILA REYES CASIMIRO, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:

Lot 5, according to the Survey of Hamlet Fourth Sector, as recorded in Map Book 9, Page 22, in the Probate Office of Shelby County, Alabama.

#### Subject to:

- 1. General and special taxes or assessments for the year 2013 and subsequent years not yet due and payable.
- 2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
- 3. Mineral and mining rights not owned by Grantors.
- 4. Any applicable zoning ordinances.
- 5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
- 6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 9, Page 22.
- 7. Transmission line permits to Alabama Power Company as recorded in Deed Book 220, Page 329.
- 8. Restrictive Covenants and conditions as set forth in Misc. Book 58, Page 117.
