**ARTICLES OF ORGANIZATION**  
**OF**  
**BSD GLOBAL, LLC**

1. The name of the limited liability company is BSD GLOBAL, LLC.
2. The limited liability company will have perpetual existence.
3. The purpose of the LLC is the organization of a company for the wholesale and retail buying and selling of previously owned motor vehicles of all types, including automobiles, motor cycles, and recreational vehicles; or for any other lawful business purpose.
