AUCTIONEER'S DEED

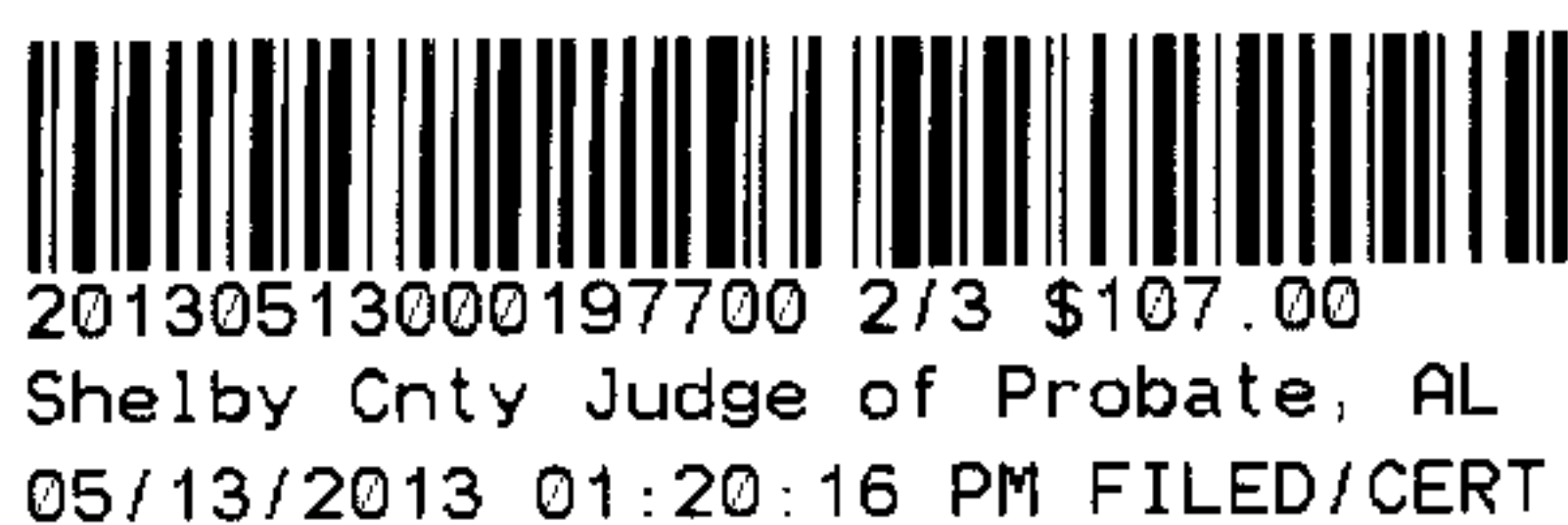
