Gregory have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto the State of Alabama the following described property:

A part of the NW ¼ of the NW ¼, Section 6, Township 21 South, Range 2 East, identified as Tract No. 31 on Project No STPBH-0025(507) in Shelby County, Alabama and being more fully described as follows:

Parcel 1 of 1:

Commencing at the northwest corner of section 6, township 21 south, range 2 east being a gun barrel found in place, thence proceed in an easterly direction along the north boundary of said section 6 for a distance of 1374.19 feet, more or less, to a point on the centerline of project STPBH-0025(507) at station 42+64.56;

Thence proceed southwesterly along the centerline of said project for a distance of 174.88 feet to a point on the centerline of project located at P.C. Station 41+31.25;

Thence N 30°21'0" E and along the required R/W line a distance of 167.37 feet to a point on the grantor's property line (said line between a point that is offset 54.00' and perpendicular to centerline of project at station 37+40.00 and a point that is offset 54.00' and perpendicular to centerline of project at station 41+00.00) ;

Thence S 89°37'18" E and along the grantor's property line a distance of 24.37 feet to a point (1" rebar found) on the present R/W line of SR 25;

Thence S 30°16'55" W and along the present R/W line of SR 25 a distance of 269.52 feet; to the point and place of BEGINNING, containing 0.13 acres, more or less;



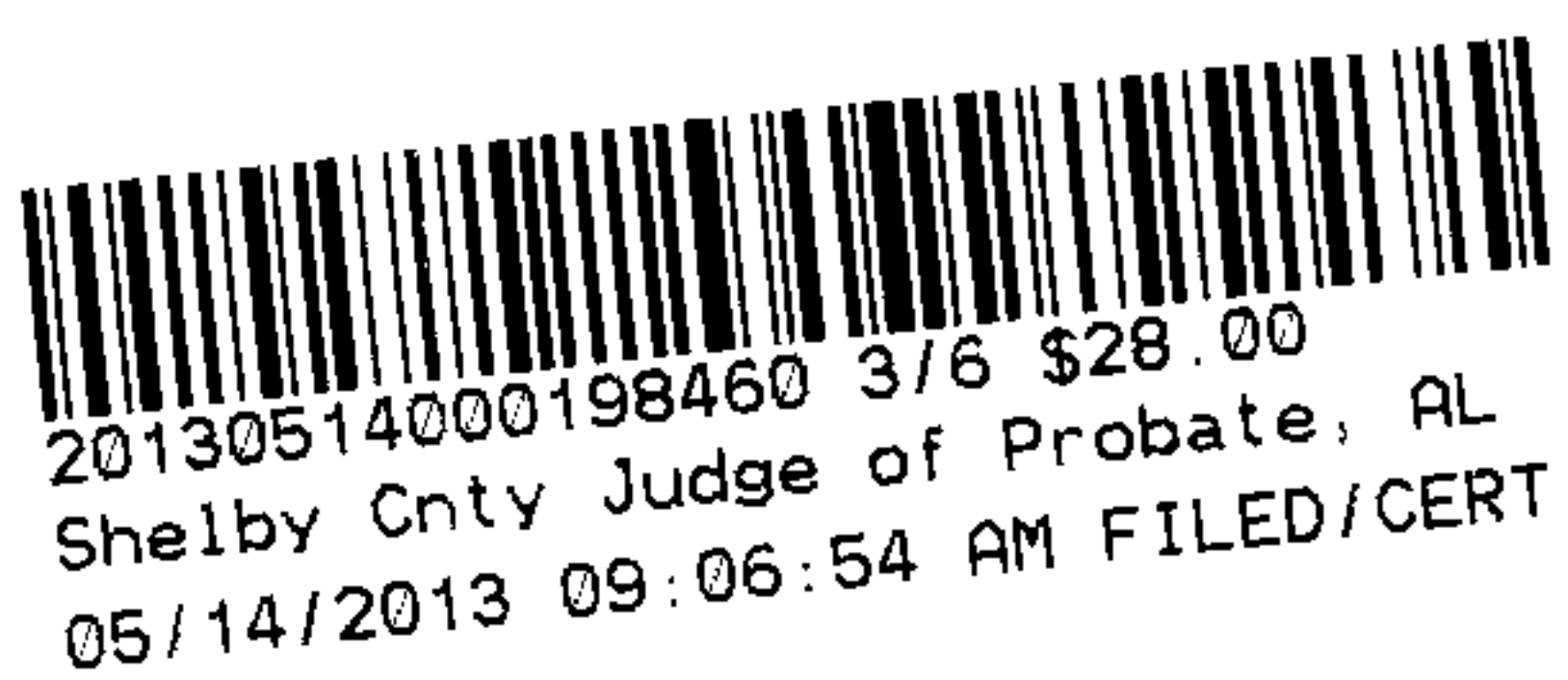

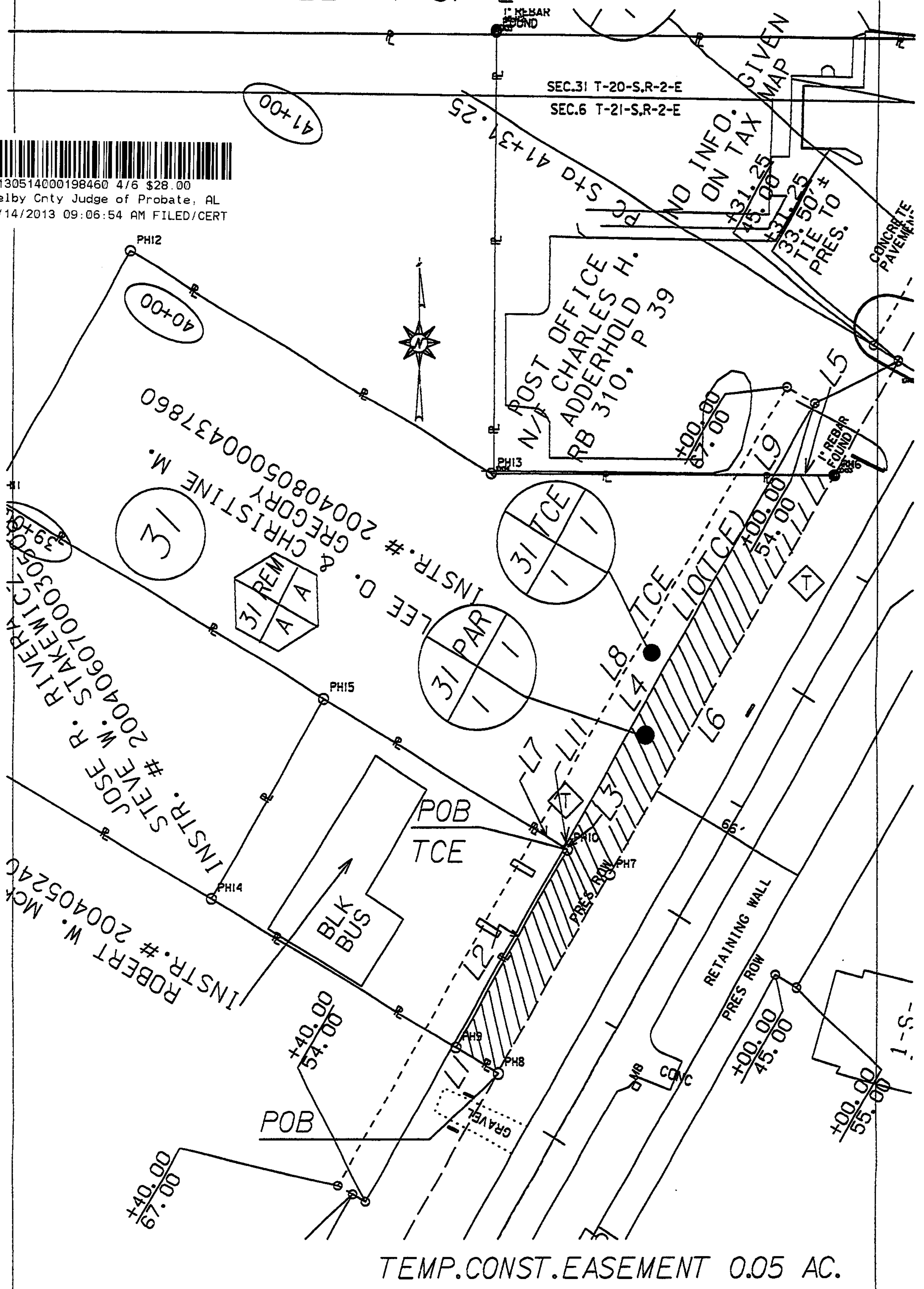
