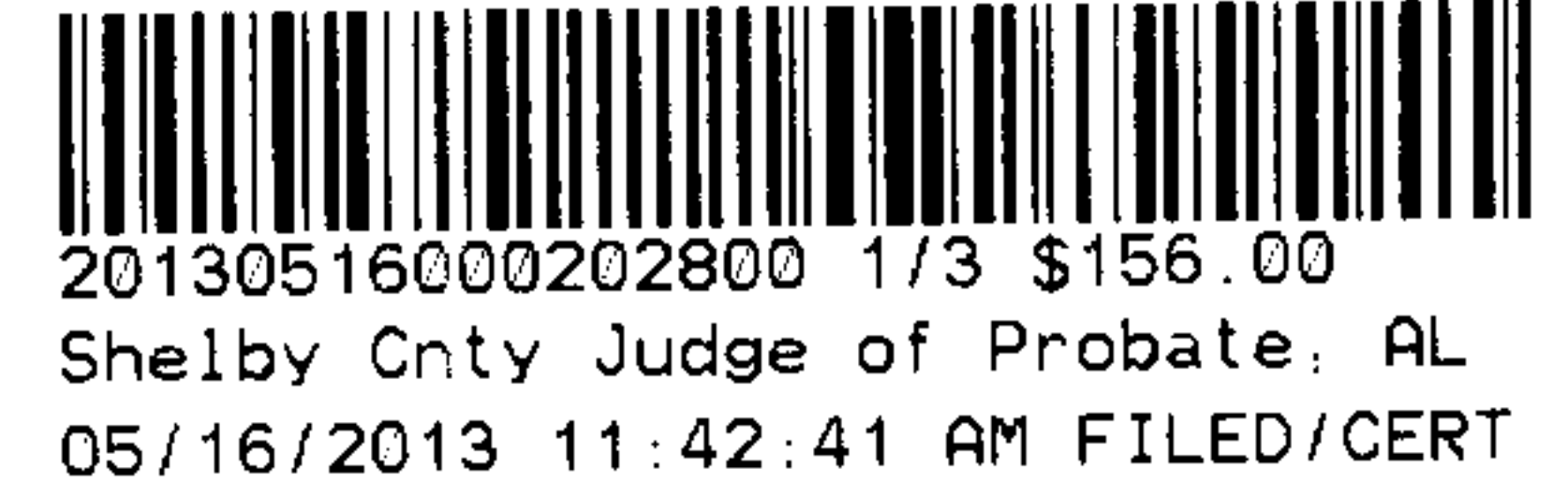


ARTICLES OF ORGANIZATION

OF

Article VIII.

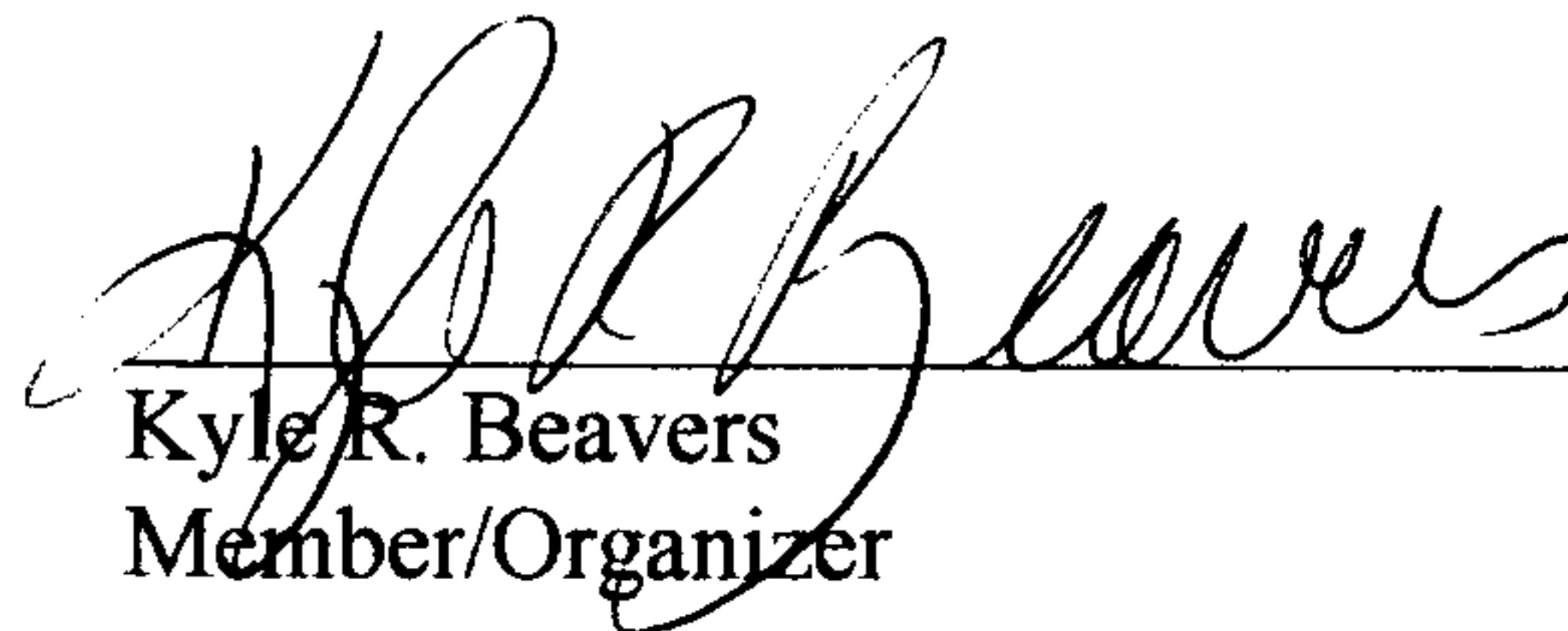
The Limited Liability Company shall have the right to continue business after an event of dissociation of one or more members, so long as at least one member remains.

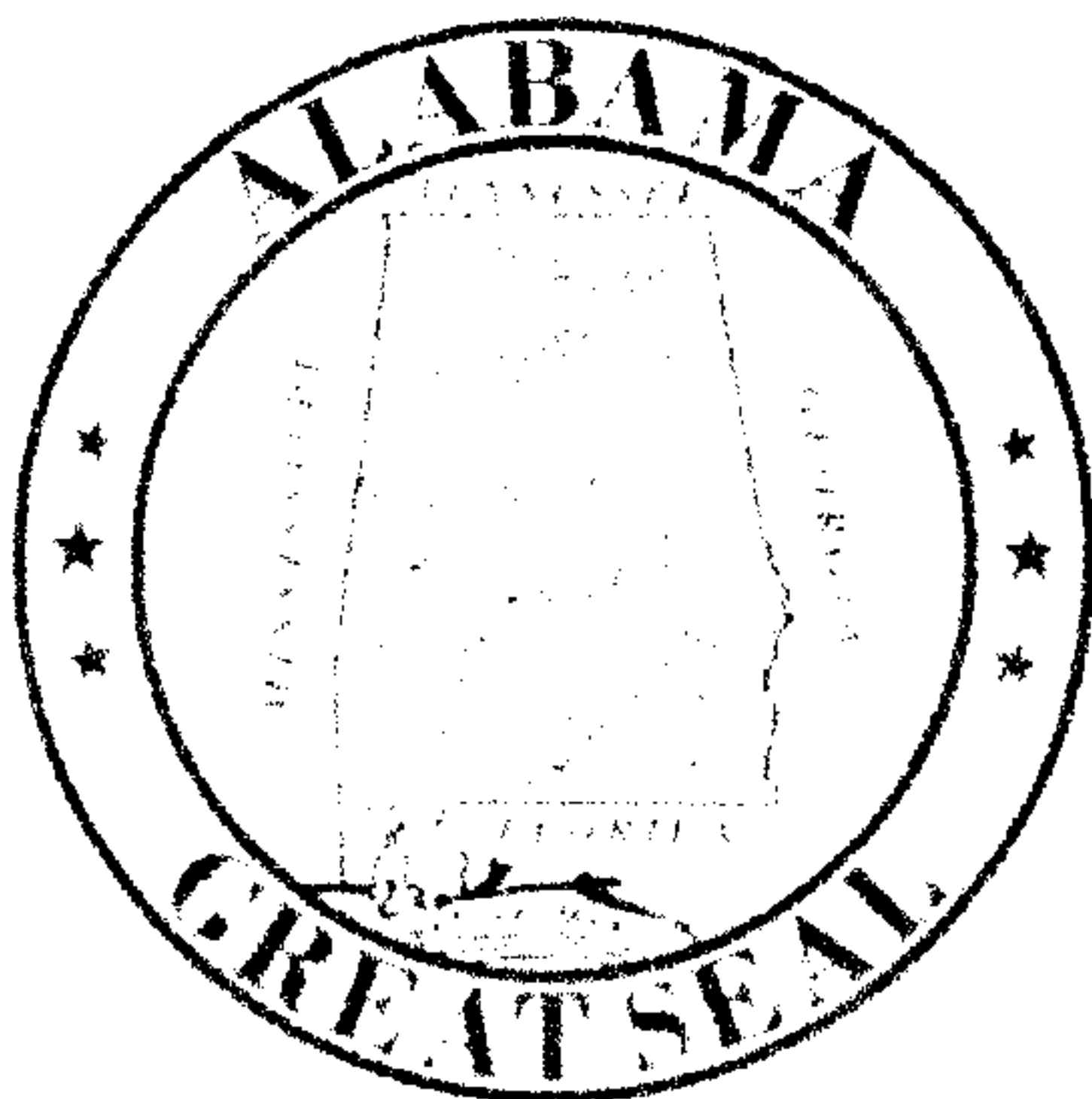
