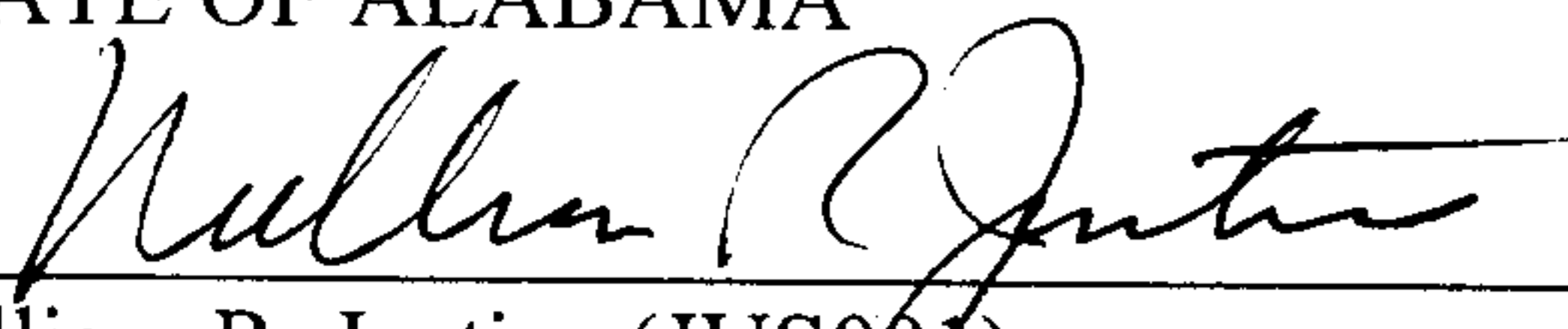
A part of the NW ¼ of NW ¼, Section 6, Township 21 South, Range 2 East, identified as Tract No. 18 on Project No STPBH 0025(507) in Shelby County, Alabama and being more fully described as follows:

Parcel 1 of 1:

Commencing at the northwest corner of Section 6, Township 21 South, Range 2 East being a gun barrel found in place, thence proceed in an easterly direction along the north boundary of said Section 6 for a distance of 1374.19 feet, more or less, to a point on the centerline of project STPBH-0025(507) at station 42+64.56; thence proceed southwesterly along the centerline of said project for a distance of 174.88 feet to a point on the centerline of project located at P.C. Station 41+31.25; thence proceed southwesterly along the centerline of said project for a distance of 721.33 feet to a point on the centerline of project located at station 34+09.92; thence turn a deflection angle 90 degrees left and proceed in a southeasterly direction for a distance of 32.99 feet, more or less, to a point (½ in. rebar found) on the present R/W line of SR 25, which is located to the left of station 34+09.92, which is the point of BEGINNING; thence N 30 deg. 20 min. 02 sec. E and along the present R/W line of SR 25 a distance of 113.23 feet to a point (½ in. open top found) on the present R/W line of SR 25; thence S 58 deg. 50 min. 44 sec. E and along the grantor's property line a distance of 12.01 feet to a point on the required R/W line (said line between a point that is offset 45.00 feet and perpendicular to centerline of project at station 33+00.00 and a point that is offset 45.00 feet and perpendicular to centerline of project at station 39+00.00); thence S 30 deg. 21 min. 0 sec. W and along the required R/W line a distance of 112.79 feet to a point on the grantor's property line (said line between a point that is offset 45.00 feet and perpendicular to centerline of project at station 33+00.00 and a point that is offset 45.00 feet and perpendicular to centerline of project at station 39+00.00); thence N 61 deg. 5 min. 54 sec. W and along the grantor's property line a distance of 12.02 feet to the point and place of BEGINNING, containing 0.03 acres, more or less.

Description of above property is taken from right of way map of said project on file in the office of State of Alabama Department of Transportation and in the Office of the Probate Judge of Shelby County, Alabama. The title of the action and the case number thereof are as hereinabove designated.
