Craft and wife, Judith O. Craft** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Brantly S. Cain and Stephanie H. Cain** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 36, according to the Survey of Heather Ridge, as recorded in Map Book 17, Page 22, in the Probate Office of Shelby County, Alabama.

Judith O. Craft is one and the same as Judith Lavender.



\$185,600.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.



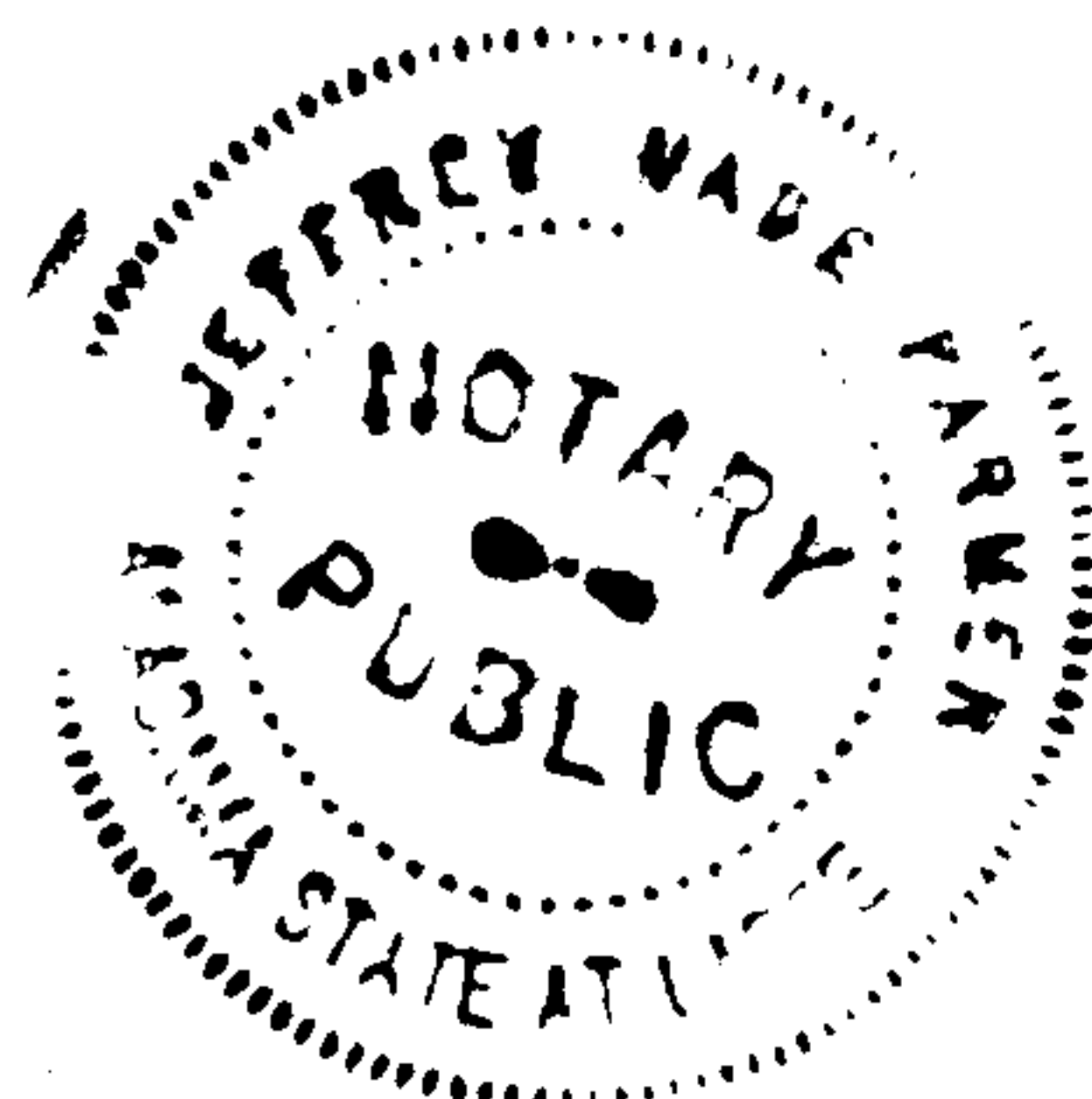
