WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this May 20, 2013, That for and in consideration of **TWO HUNDRED SEVENTY ONE THOUSAND FIVE HUNDRED AND NO/100 (\$271,500.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **MICKEY HARDY and ANNE HARDY (being the one and the same person also known as Anne Stanton)**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **MIRANDA C. LEBLANC and GERALD L. LEBLANC**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1, according to the Survey of Legacy Parc, as recorded in Map Book 27, Page 9, in the Office of the Judge of Probate of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to:

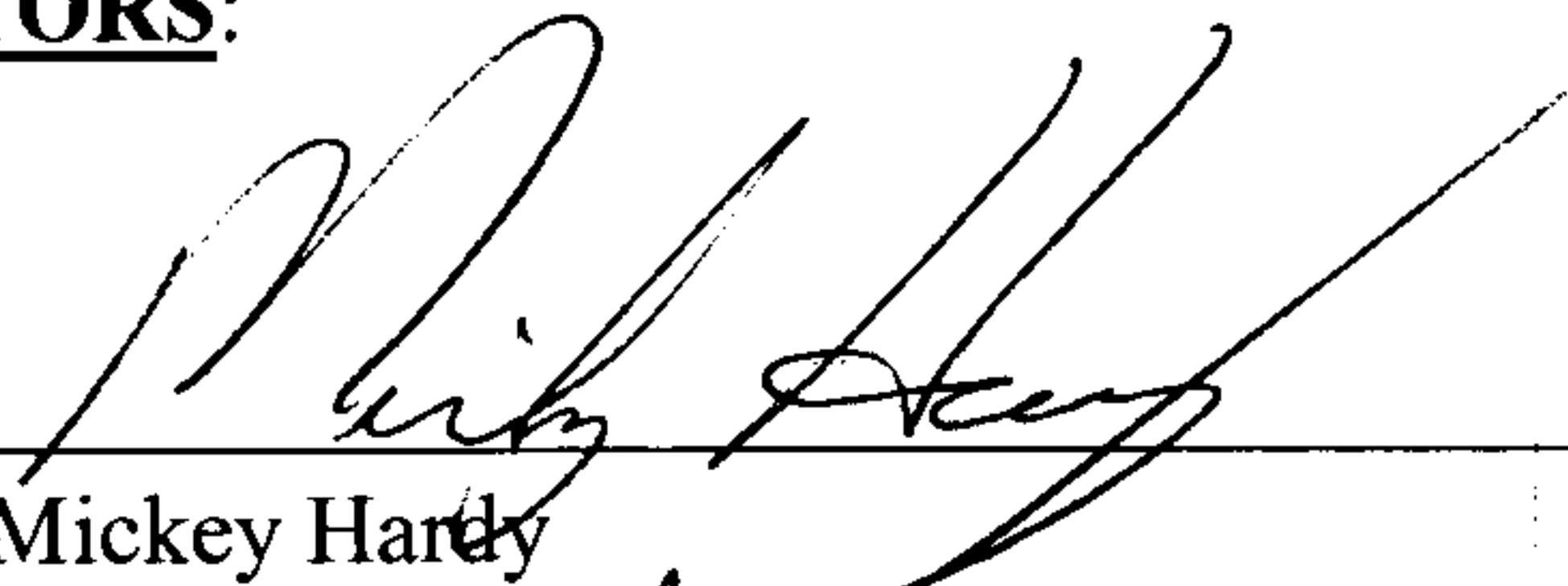
1. General and special taxes or assessments for the year 2013 and subsequent years not yet due and payable.

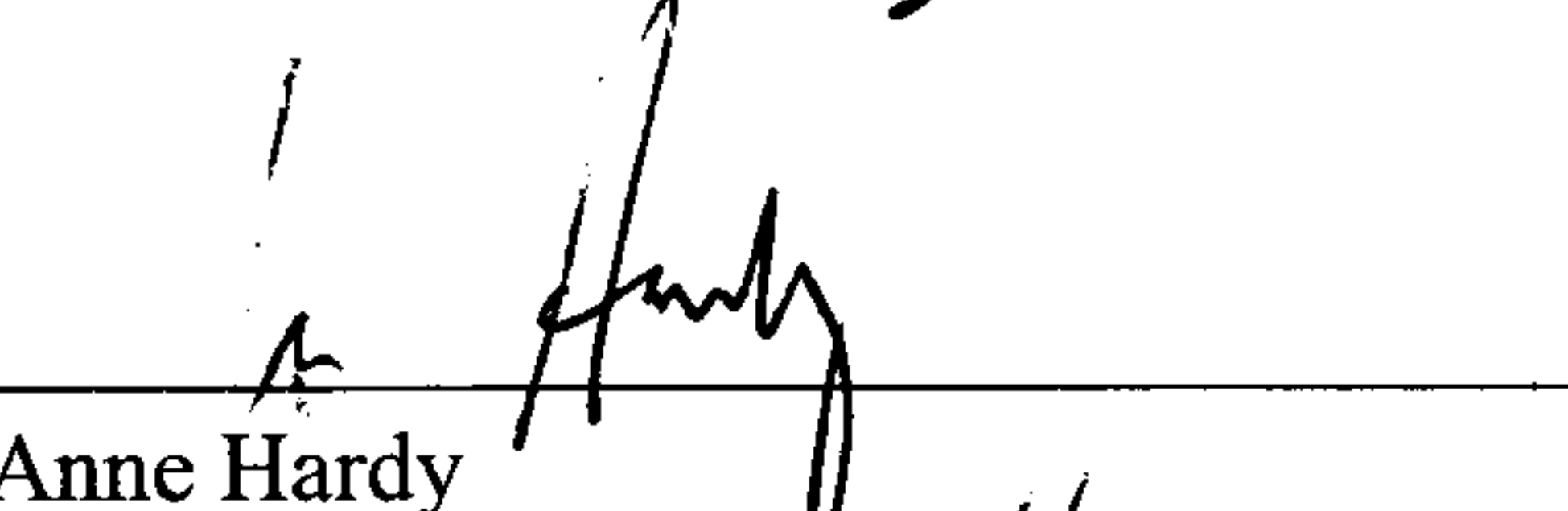

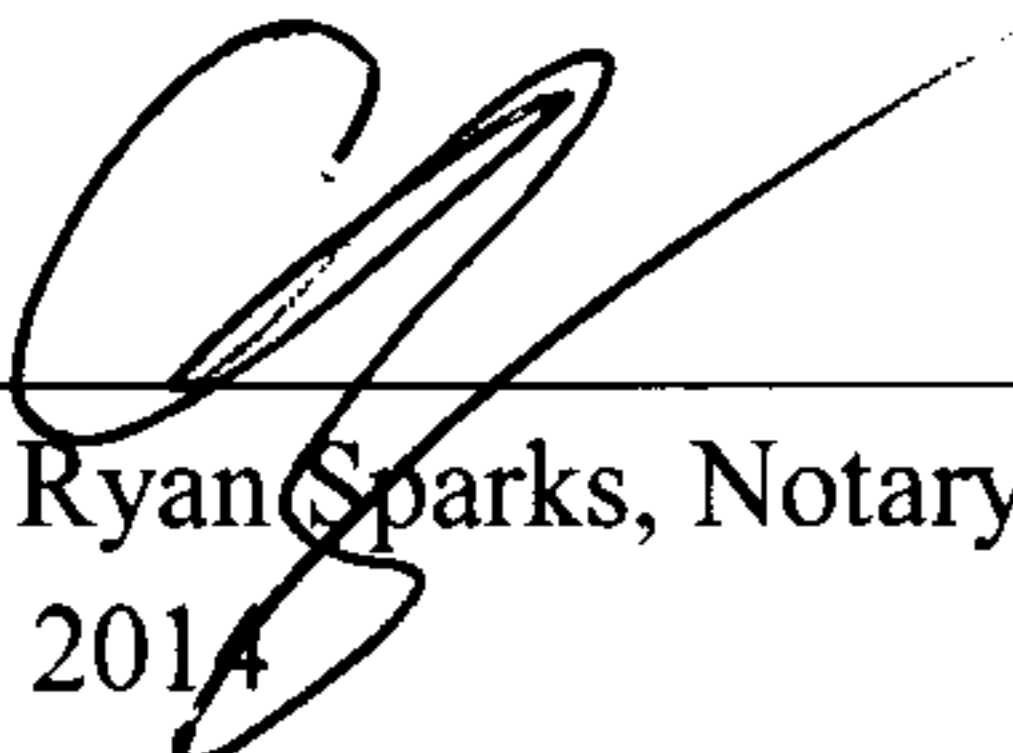
