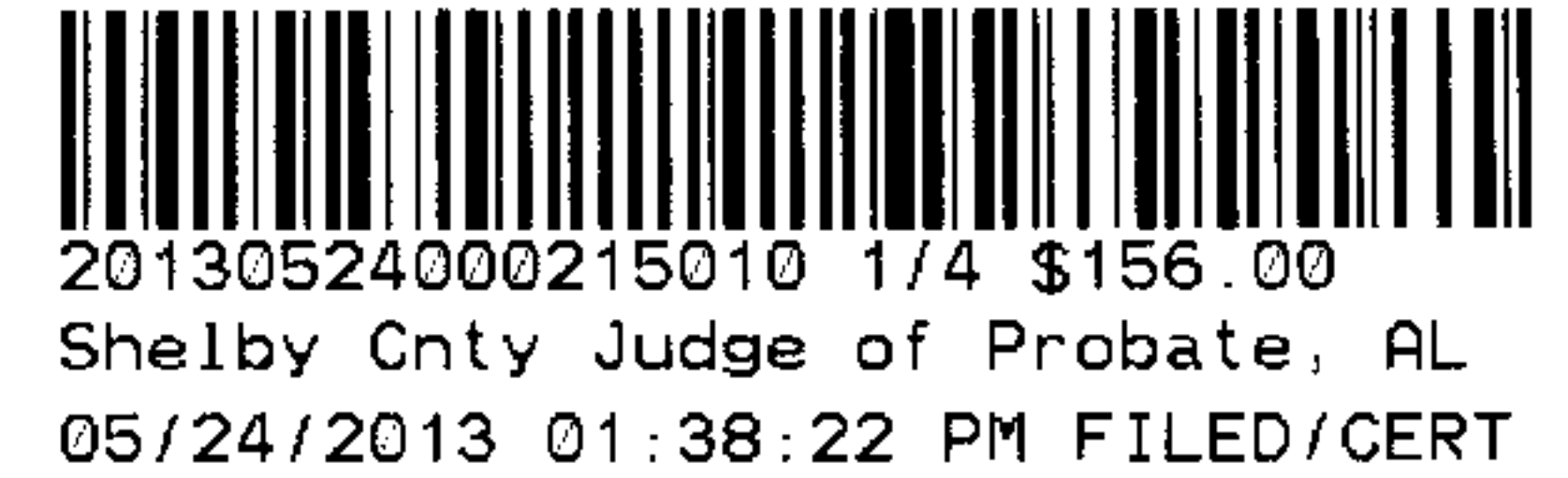


**ARTICLES OF ORGANIZATION OF
MEDI-SERV, LLC**



Pursuant to the Provisions of Section 10-2-1, et seq., of Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

The name of the limited liability company is Medi-Serv, LLC (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until perpetual unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Purposes

The purposes for which the Company is formed are:

- A) To engage in the business of providing repair and maintenance to medical and electronic devices used in treating patients.
- B) To engage in any other lawful act or activity for which limited liabilities companies may be organized pursuant to the Act.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be located at 15 Sharpsburg Circle, Calera, Alabama 35040. The registered agent shall be Larry Bowles.

ARTICLE VII

Cessation of Membership

The cessation of membership of one or more members will result in the dissolution of the Company unless the membership takes action to amend this article.

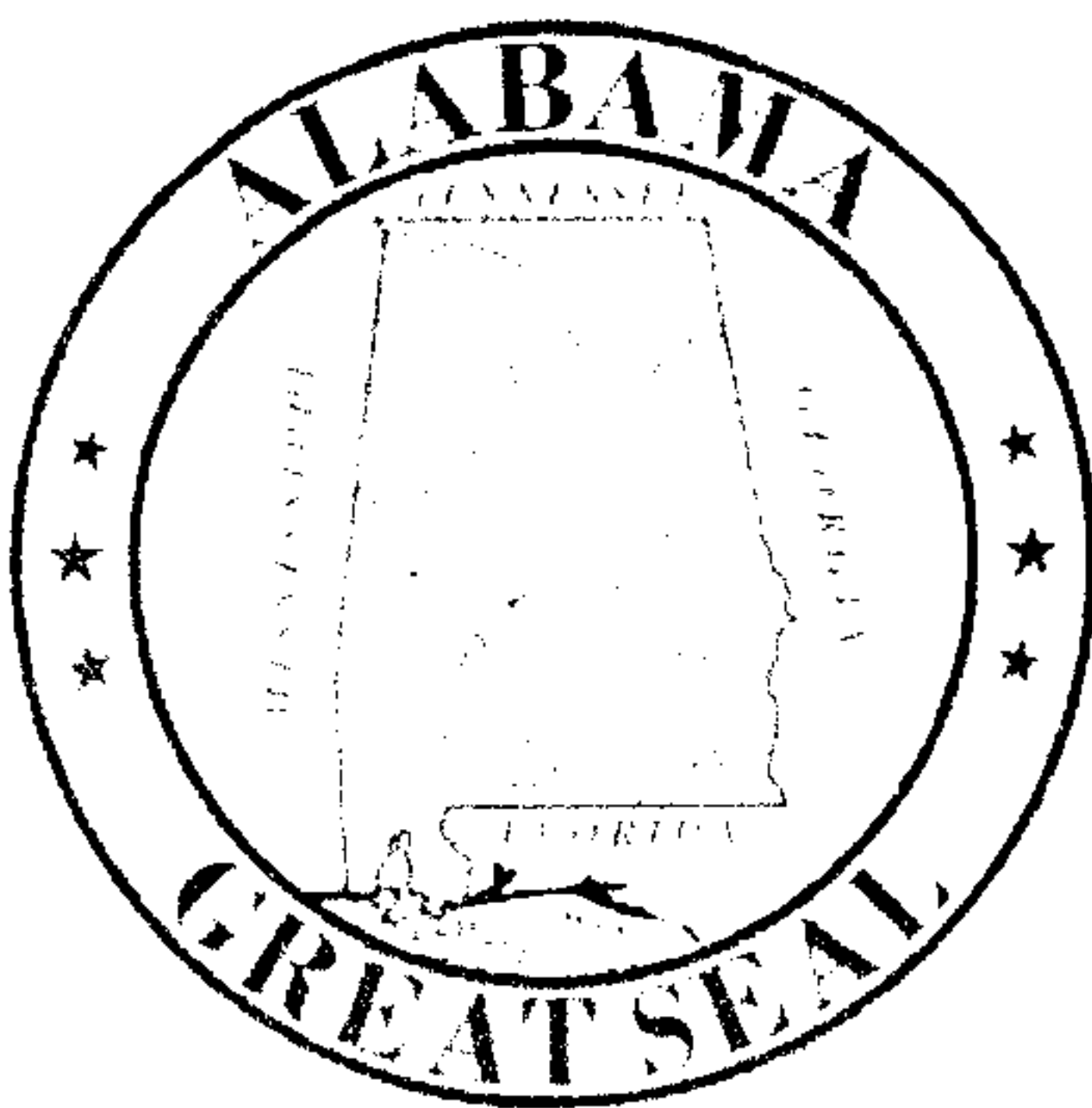
