Know All Men by These Presents: That in consideration of **Two hundred fifty nine thousand and no/100 (\$259,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Acton Land Company, L.L.C.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Walter Joe Parker, Jr. and Julie Irwin Parker** (herein referred to as grantee, as joint tenants of survivorship, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

This instrument is executed as required by the Articles of Organization and Operating Agreement and same have not been modified or amended.


Acton Land Company, LLC and Acton Land Company, L.L.C. are one and the same entity.


