

AUCTIONEER'S DEED

WHEREAS, MOHAMMAD B. TOOLABI and his wife, WANDA L. TOOLABI, (Mohammad B. Toolabi and (Mike) Mohammad B. Toolabi are one and the same) executed a mortgage to Mortgage Electronic Registration Systems, Inc. 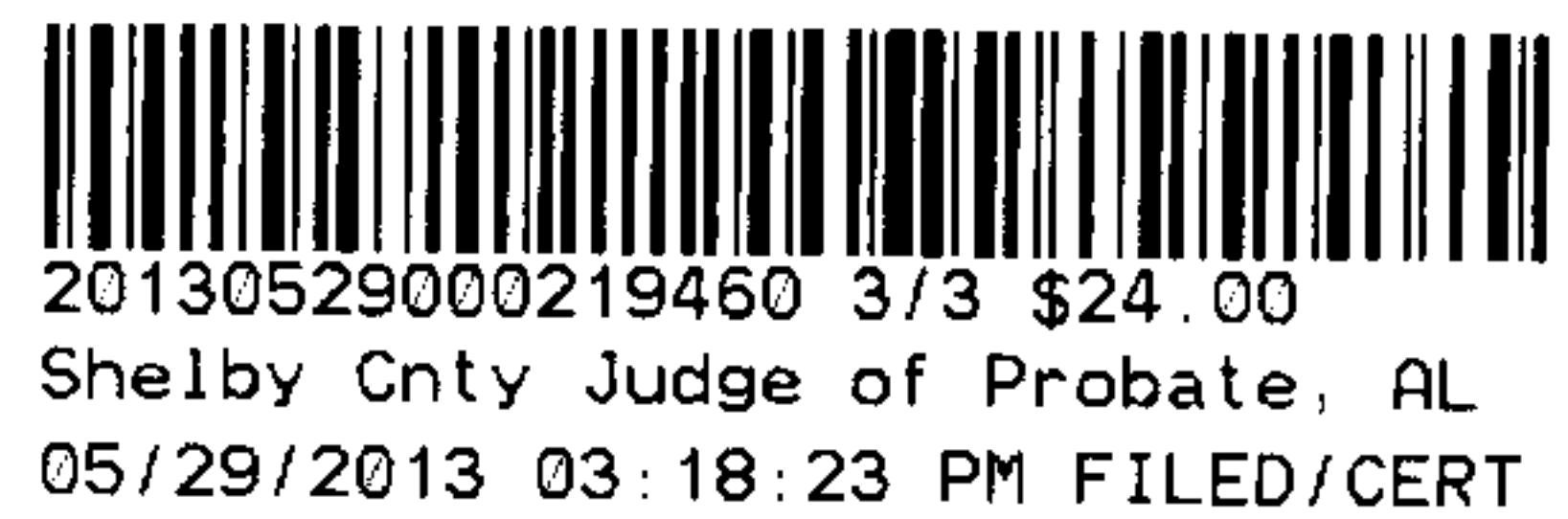
