

ARTICLES OF INCORPORATION OF DR EARL CUNNINGHAM OUTREACH AND EDUCATIONAL SCHOLARSHIP FUND, INC

We, the undersigned, acting as incorporators of a corporation under the Alabama Non-Profit Corporation Act, §§10-3A-1 to 10-3A-225 of the *1975 Alabama Code*, hereby sign, verify, and file the following articles of incorporation:

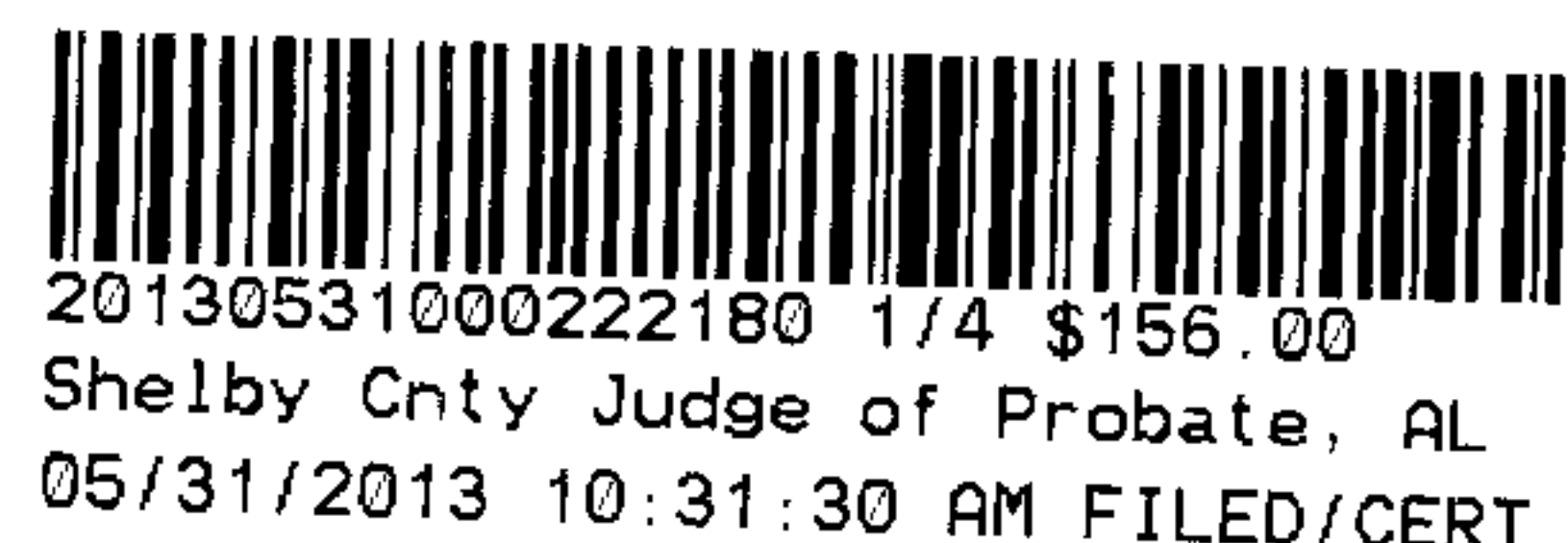
- ① The name of the corporation shall be: Dr Earl Cunningham Outreach and Educational Scholarship Fund, Inc
- ② The period of duration of the corporation shall be perpetual.
- ③ The purposes for which the corporation is organized shall be charitable, benevolent, eleemosynary, educational, and civic.
- ④ The corporation shall have one class of members. No member shall profit or otherwise derive pecuniary gain from his, her, or its membership.
- ⑤ The directors shall be elected by the members.
- ⑥ The internal affairs of the corporation shall be regulated by the bylaws, consistently with applicable law and these articles.

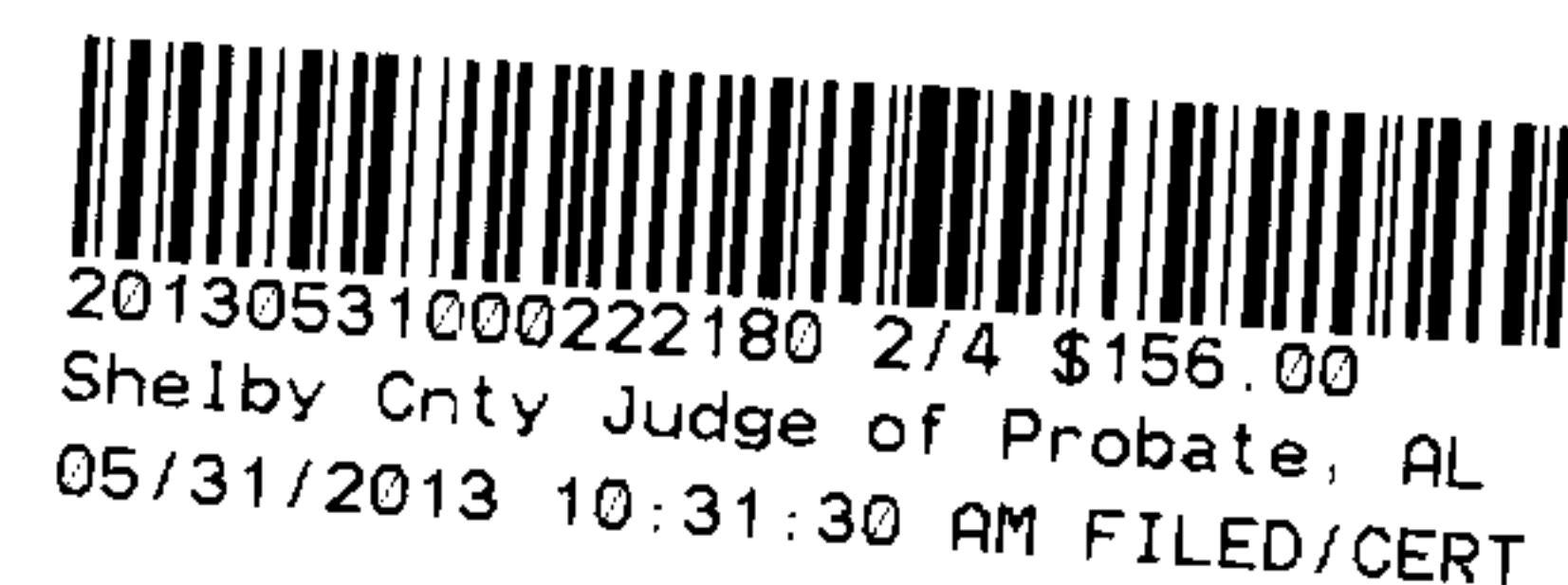



(11) Notwithstanding any of the powers or purposes of the corporation contained in this certificate of incorporation or granted by law, this corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, nor shall it engage in any activity of any kind whatever involving the carrying on of propaganda, nor shall it attempt in any manner to influence legislation, nor shall it engage in any activities which are not in themselves tax-exempt under the Internal Revenue Code of the United States of America. If the corporation is ever dissolved, its assets shall be distributed in accordance with the provisions of §10-3A-141 of the 1975 *Alabama Code*, or successor legislation then in effect, and also in accordance with §501(c)(3) and other provisions of the United States Internal Revenue Code regulating nonprofit corporations.
