That in consideration of Thirty Thousand dollars and Zero cents (\$30,000.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, Sherry Owens, a single woman (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Michael Blake Wydemon (herein referred to as grantee, whether one or more), the following described real estate, situated in Sumter County, Alabama, to-wit:

A parcel of land in the NW 1/4 of Section 9, Township 19 South, Range 2 East, described as follows:


TO HAVE AND HOLD to the said grantee, his, her or their heirs and assigns forever.






