### Subordination Agreement

THIS AGREEMENT is made and entered into on this 9th day of May, 2013, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of NAVY FEDERAL CREDIT UNION AND/OR THE SECRETARY OF VETERAN AFFAIRS, AN OFFICER OF THE UNITED STATES OF AMERICA, ISAOA, ATIMA, its successors and assigns (hereinafter referred to as "Lender").

### RECITALS

Regions Bank loaned to Roberto S Orosco (the "Borrower", whether one or more) the sum of \$37,000.00. Such loan is evidenced by a note dated August 29, 2007, executed by Borrower in favor of Regions Bank, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded 9/21/2007, Instrument # 20070921000443390 in the public records of SHELBY COUNTY, AL (the "Regions Mortgage"). Borrower has requested that lender lend to it the sum of \$136,994.00 which loan will be evidenced by a promissory note, and executed by Borrower in favor of Lender (the "Note"). The Note will be secured by a mortgage of the same date as the Note (the "Mortgage"). Lender and Borrower have requested that Regions Bank execute this instrument.

### AGREEMENT

In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, Regions Bank agrees that the Mortgage shall be and remain at all times a lien or charge on the property covered by the Mortgage prior and superior to the lien or charge of Regions Bank to the extent the Mortgage secures the debt evidenced by the Note and any and all renewals and extensions thereof, or of any part thereof, and all interest payable on all of said debt and on any and all such renewals and extensions, and to the extent of advances made under the Note of the Mortgage necessary to preserve the rights or interest of Lender thereunder, but not to the extent of any other future advances.

By its acceptance of this agreement, the borrower agrees to pay the subordination Fee set out in the Regions Subordination Request Form.
