KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of **Two Hundred Seventeen Thousand and 00/100 (\$217,000.00)** and other valuable considerations to the undersigned GRANTOR (S), **MELANY MORGAN, AN UNMARRIED INDIVIDUAL**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEE (S) herein, the receipt of which is hereby acknowledged, the said GRANTOR (S) does by these presents GRANT, BARGAIN, SELL and CONVEY unto **BRIAN CONNOR MCMAHON and KIMBERLY ANN MCMAHON**, hereinafter referred to as GRANTEE(S), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in County of Shelby State of Alabama, to-wit:

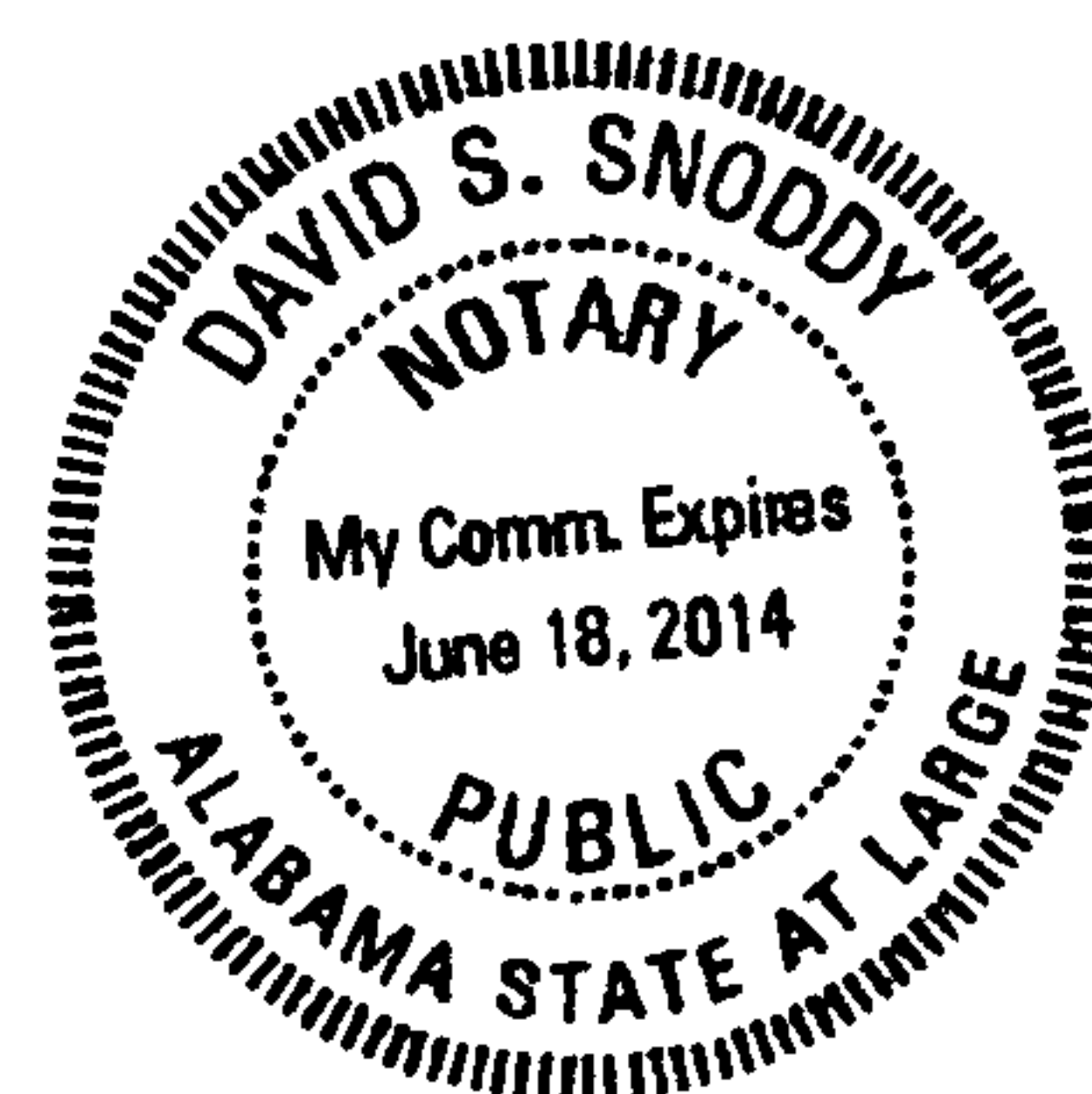
