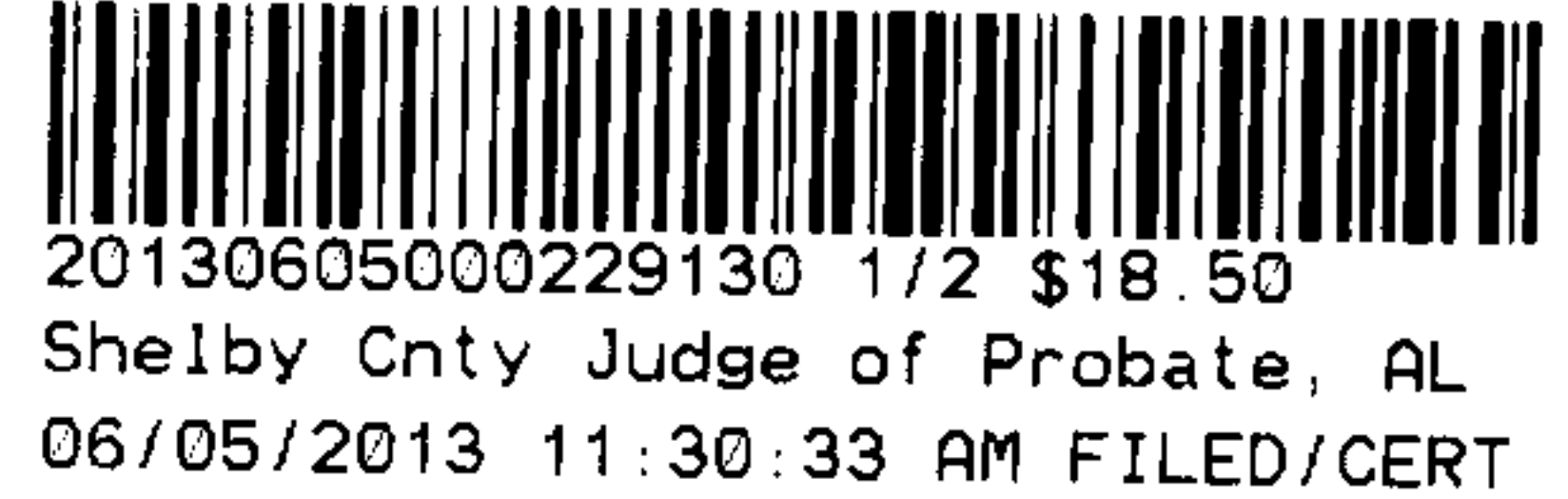

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Eighty-Seven Thousand Five Hundred And No/100 Dollars (\$187,500.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Daniel D. Ellsworth and wife, Karen S. Ellsworth (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Douglas C. Hammac, Jr. and Tammy S. Hammac (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 27, according to the Survey of Forest Hills, 1st Sector, as recorded in Map Book 19, Page 46 A & B, Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

One Hundred Eighty-Four Thousand One Hundred Three And No/100 Dollars (\$184,103.00) of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.

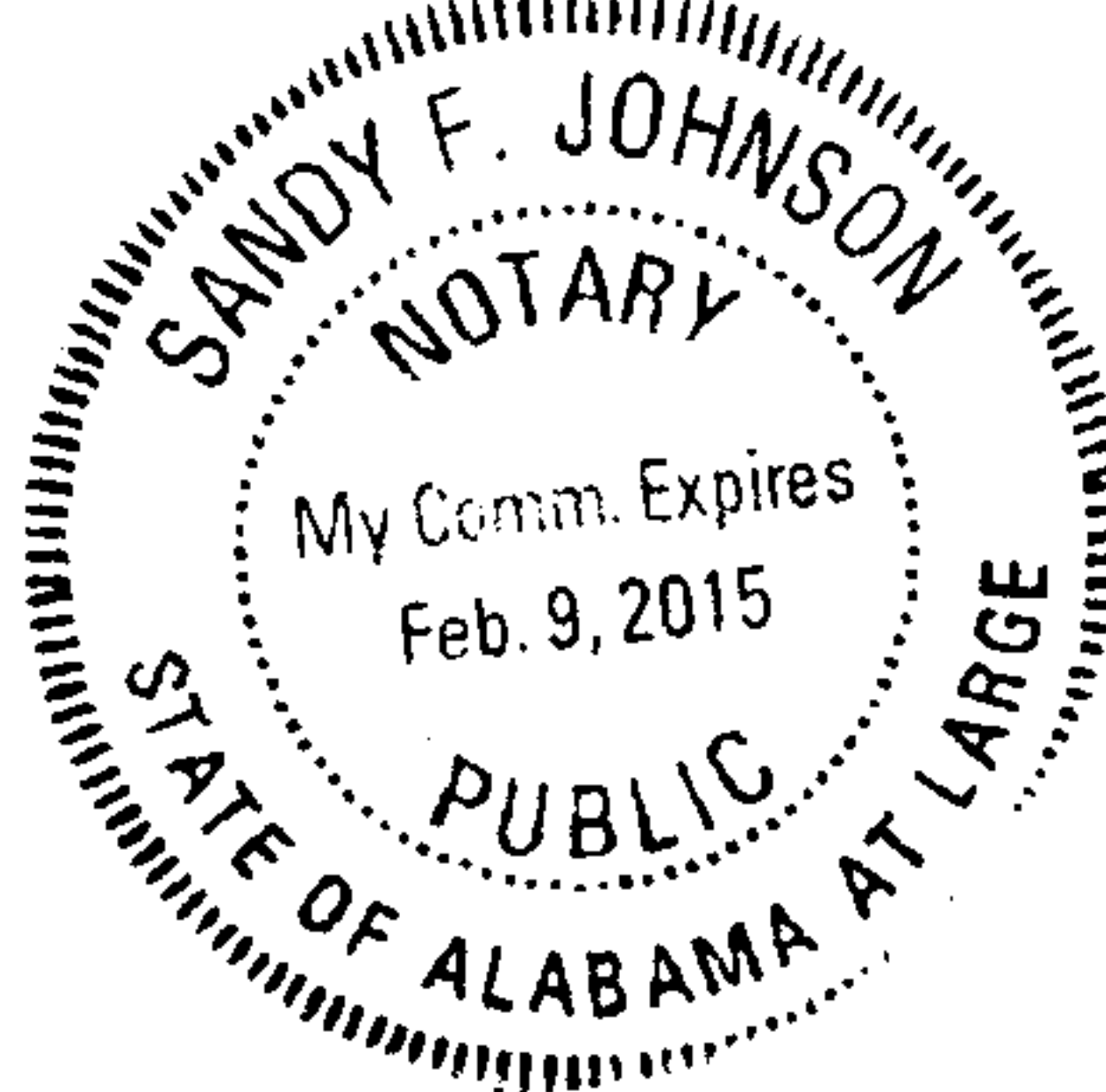


