

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of February, 2005, Moiz Ahmed and spouse Humaira Moiz, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for First Magnus Financial Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050308000105660, said mortgage having subsequently been transferred and assigned to Pennymac Mortgage Investment Trust Holdings I, LLC, by instrument recorded in Instrument Number 20120806000285100, in the aforesaid Probate Office ("Transferee"); and

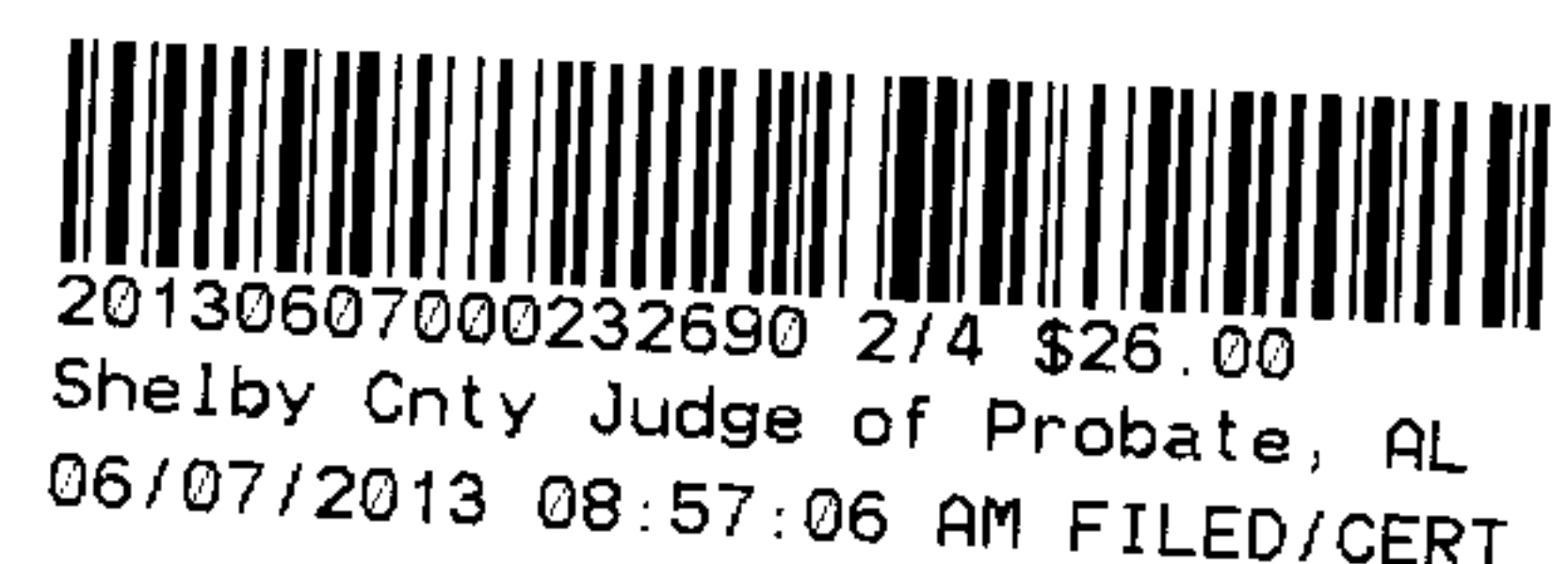
