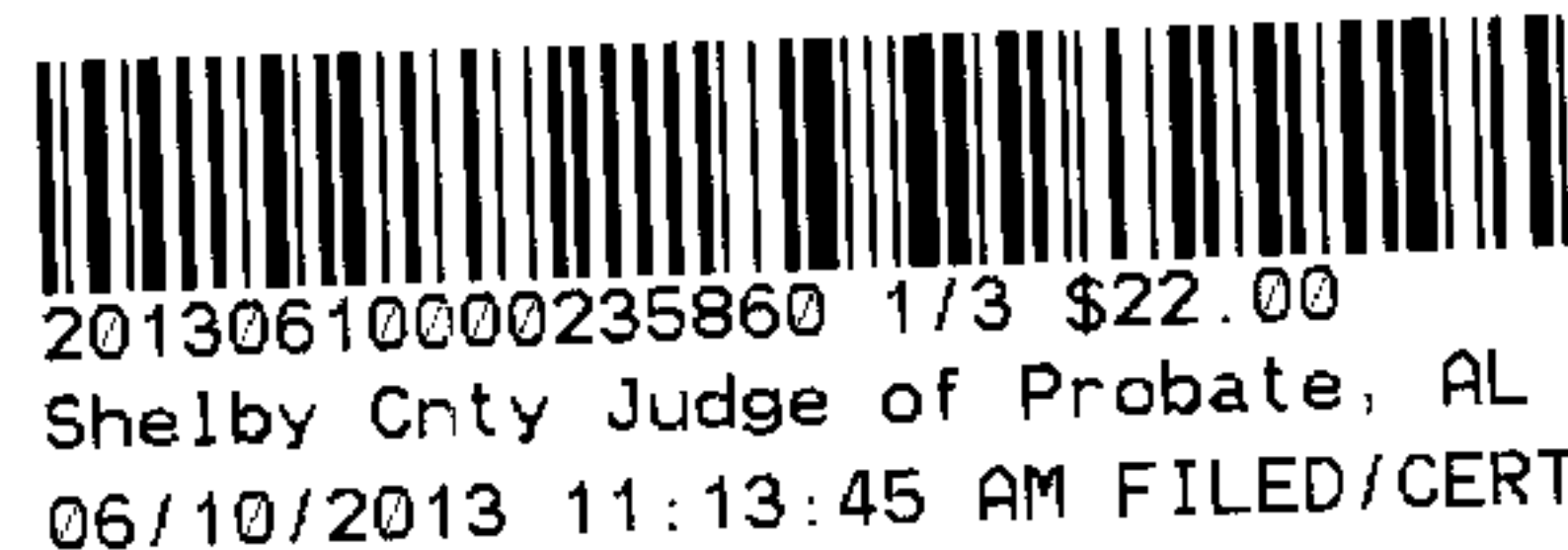

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 27, 2004, **Jeffrey Richardson And Meghan Richardson, husband and wife, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc acting solely as nominee for Primary Capital Advisors, LC, its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20041029000599050, in the Office of the Judge of Probate of Shelby County, Alabama. 


