KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of October, 2004, Thomas E Seales, Jr. and wife Krystin Seales, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hamilton Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument 20041027000592720, said mortgage having subsequently been transferred and assigned to U.S. Bank, National Association, by instrument recorded in Instrument Number 20120815000301690, in the aforesaid Probate Office ("Transferee"); and

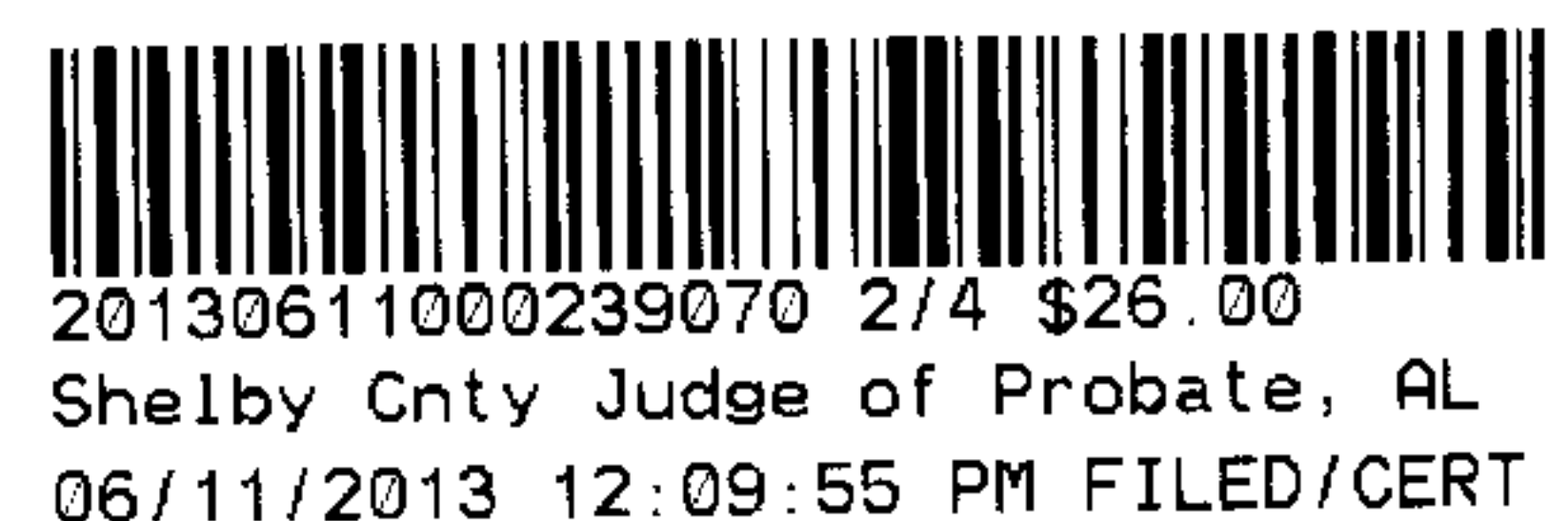

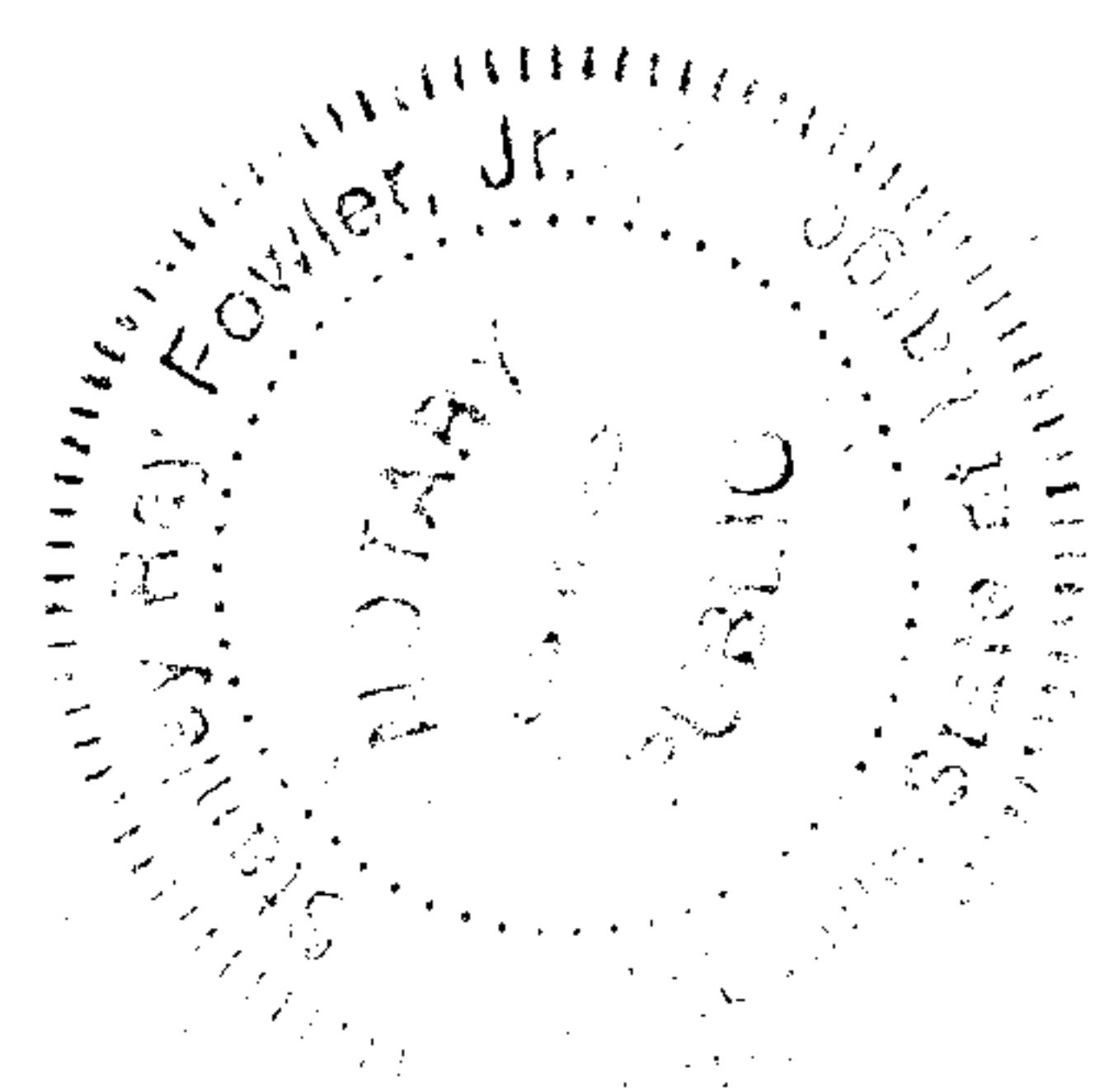
