

CERTIFICATE OF LIMITED PARTNERSHIP OF FRENCH FARMS VILLAGE APARTMENTS, LTD.

- 6. The term for which the Partnership is to exist is from the execution and filing of this Certificate until the close of business on December 31, 2066 or when all of the partners agree to a dissolution of the Partnership or as otherwise provided in the Agreement of Limited Partnership.
- 7. Except as otherwise provided in the Agreement of Limited Partnership or by the unanimous consent of all partners, no partner shall have the power to grant to an assignee of any part of such partner's partnership interest to become a partner.


