WHEREAS, heretofore, on, to-wit: the 14th day of March, 2008, James E. Coyle and wife, Grace M. 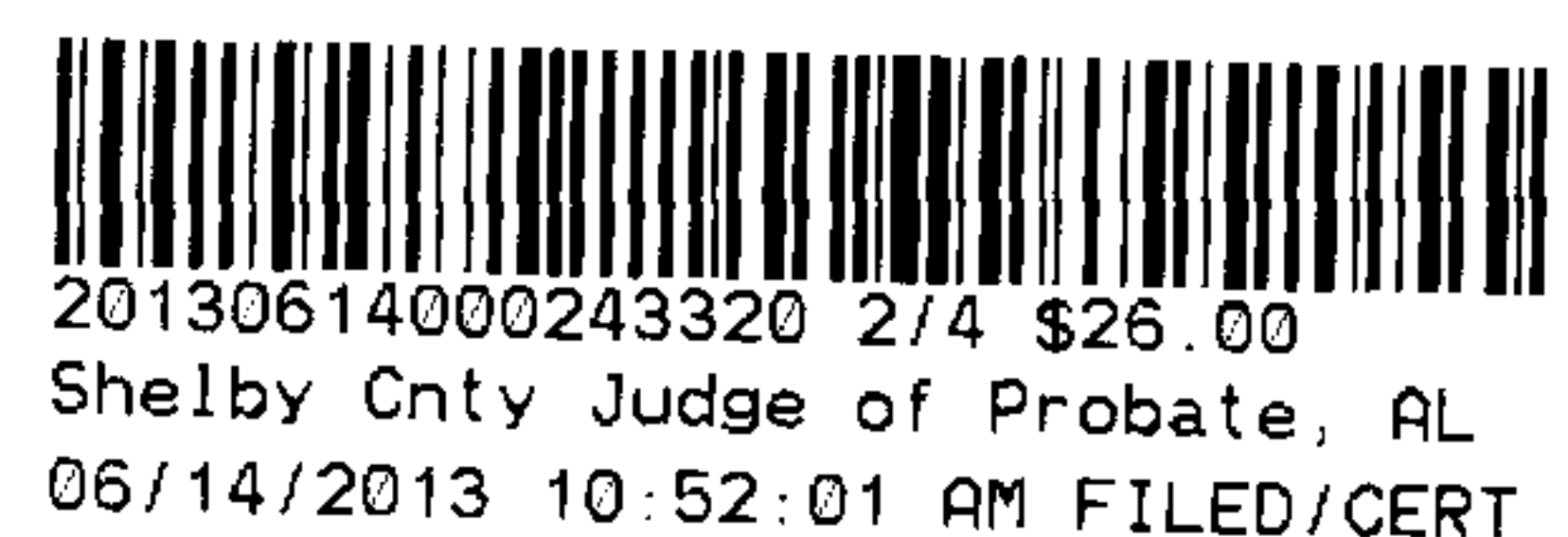

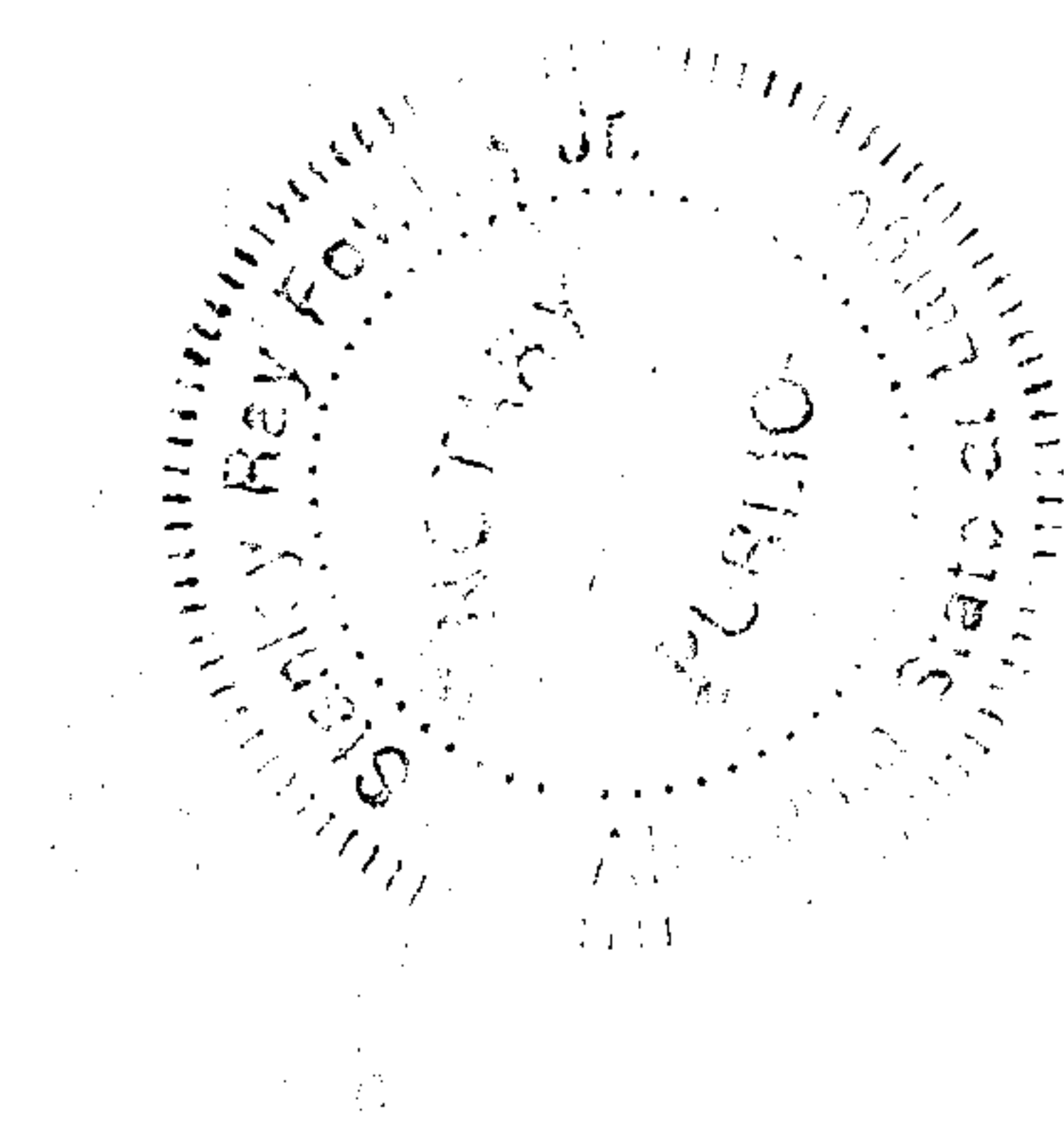

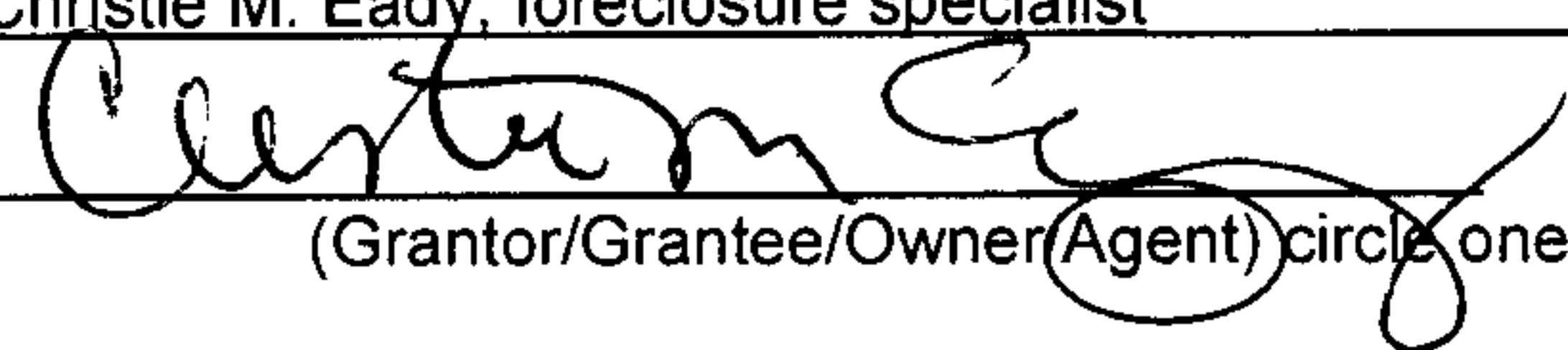
