KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of September, 2007, Jerry Looman, Jr., and Saria Lauren Looman, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for The Mortgage Outlet, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071005000467700, said mortgage having subsequently been transferred and assigned to M&T Bank, by instrument recorded in Instrument Number 20130328000129250, in the aforesaid Probate Office ("Transferee"); and

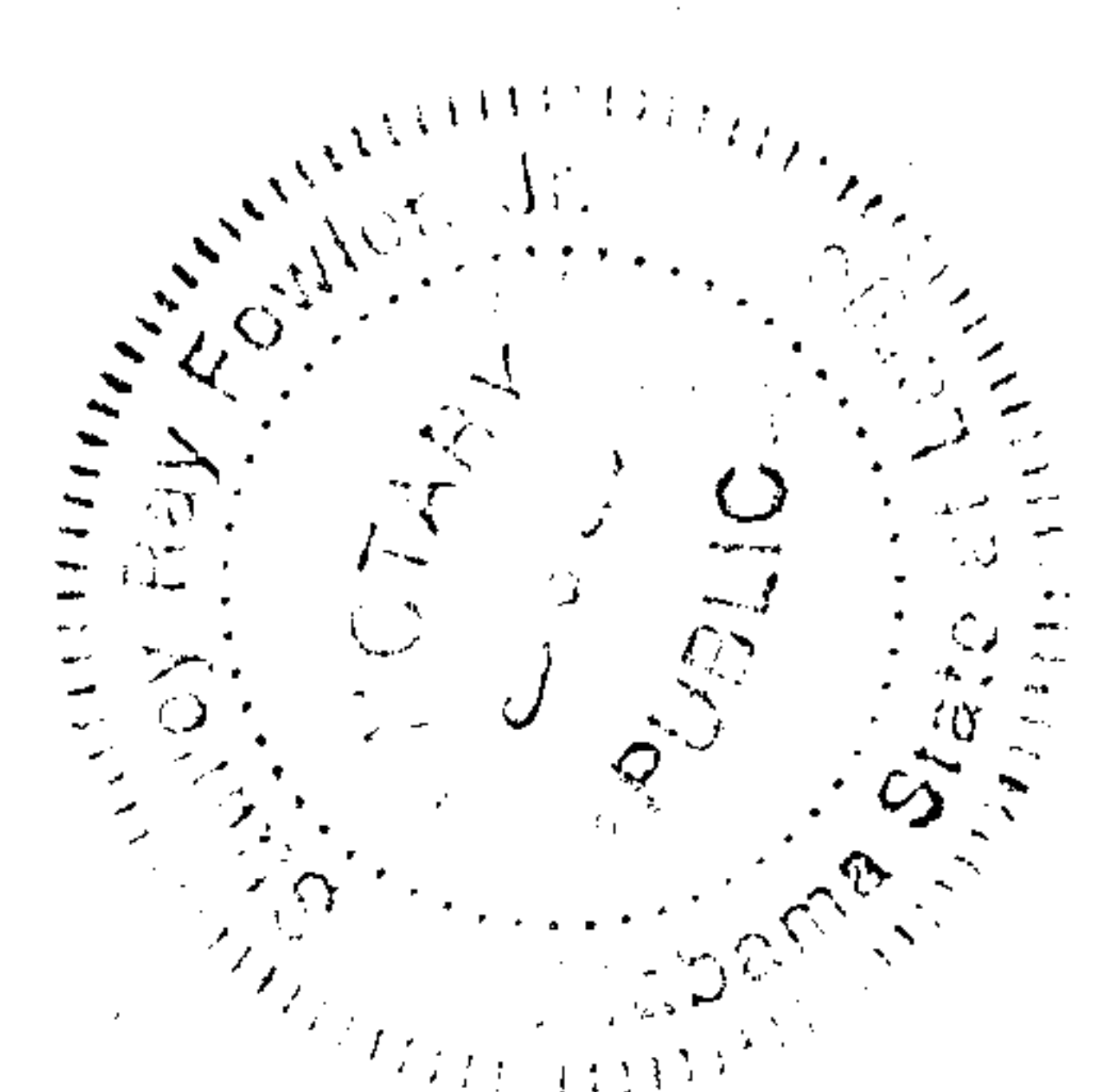
