KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of December, 2005, Mary Tabitha Shirey and Charles Shirey, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Wilmington Finance, a division of AIG Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051220000655860, said mortgage having subsequently been transferred and assigned to U.S. Bank, National Association, as Trustee for The Holders of The Specialty Underwriting and Residential Finance Trust, Mortgage Loan Asset-backed Certificates, Series 2006-BC2, by instrument recorded in Instrument Number 20120509000163570, in the aforesaid Probate Office ("Transferee"); and

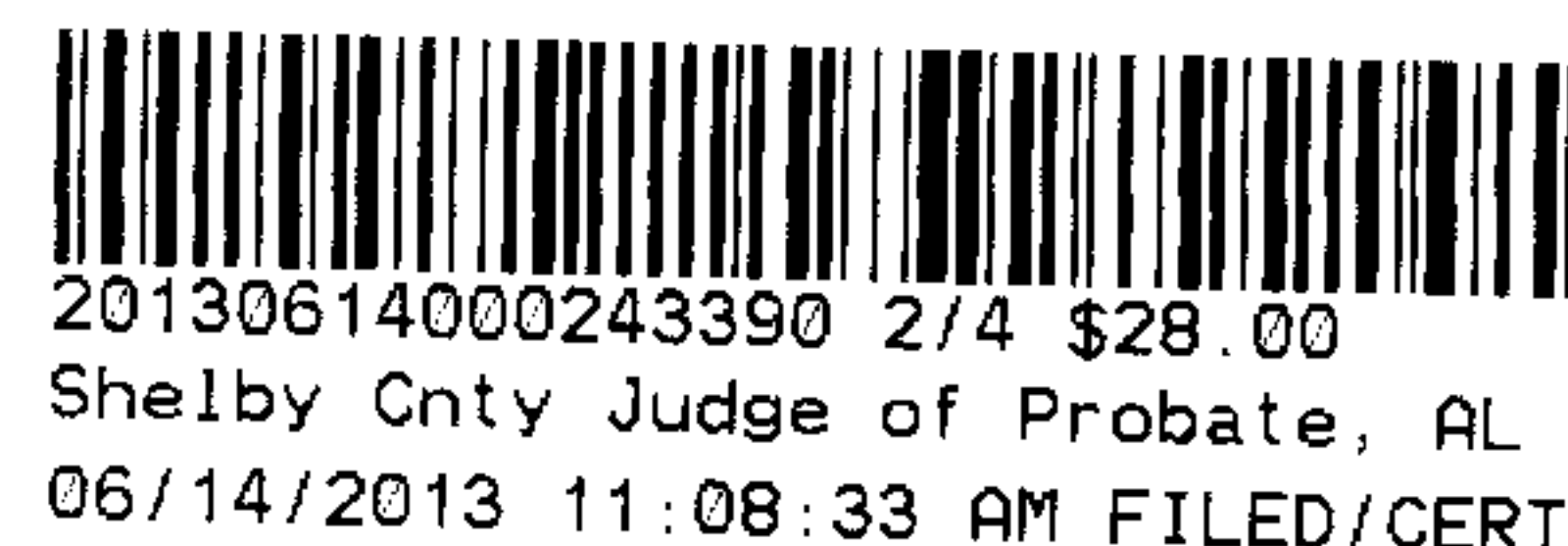



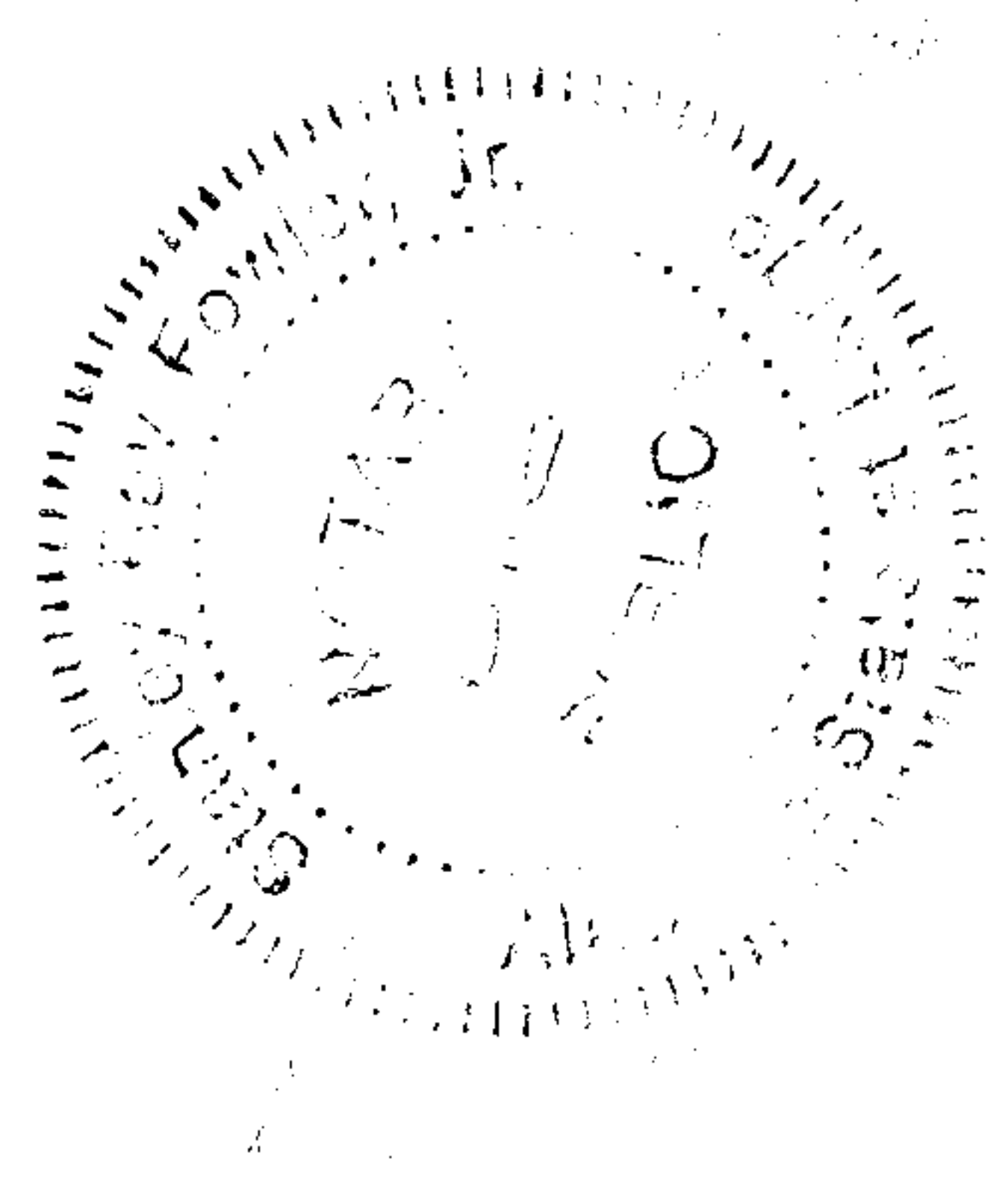
