This instrument is executed as required by the Articles of Organization and Operational Agreement of said LLC and same have not been modified or amended.


All of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.

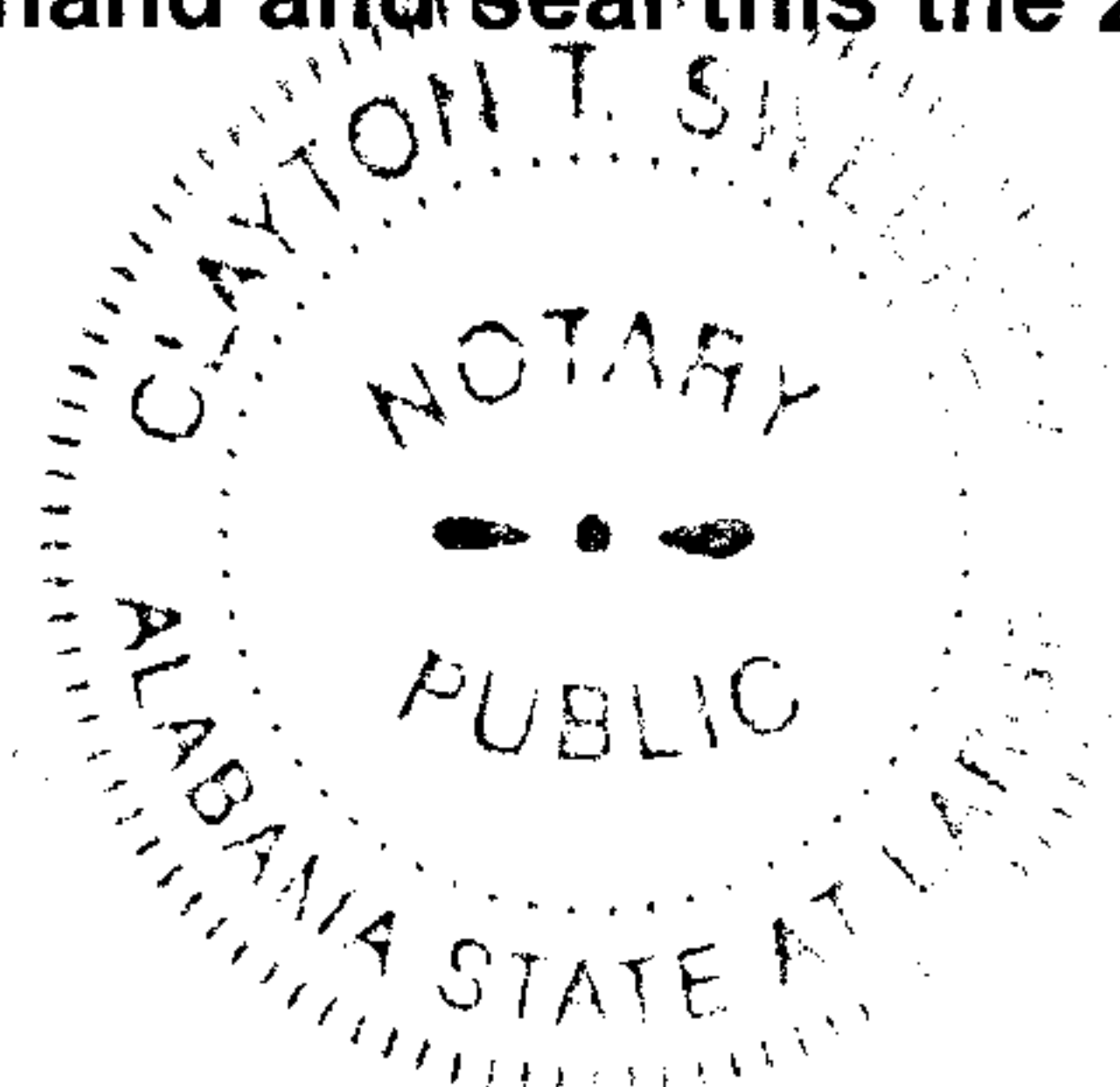
