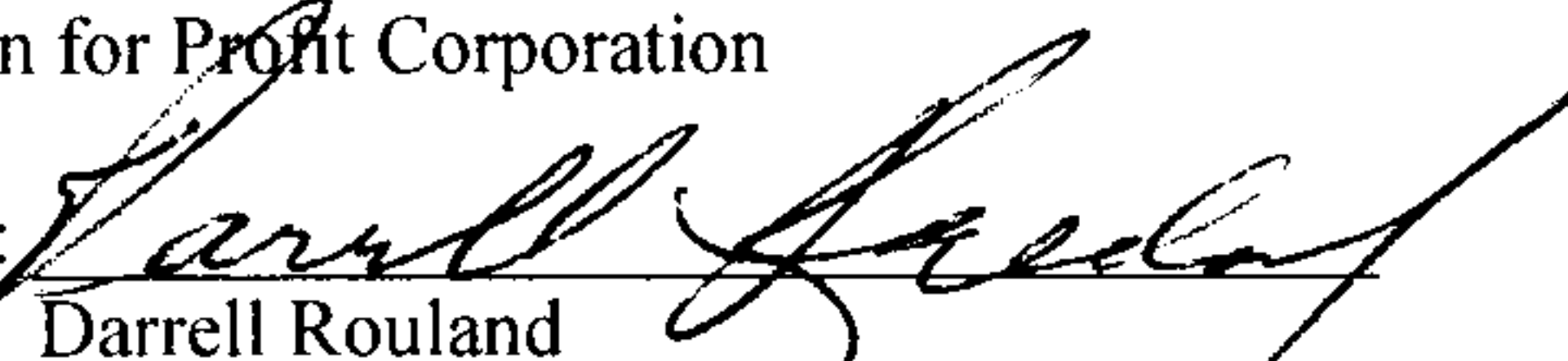
The Association claims a lien upon property owned by **Kristen Leonard**, situated in Shelby County, Alabama described as follows:

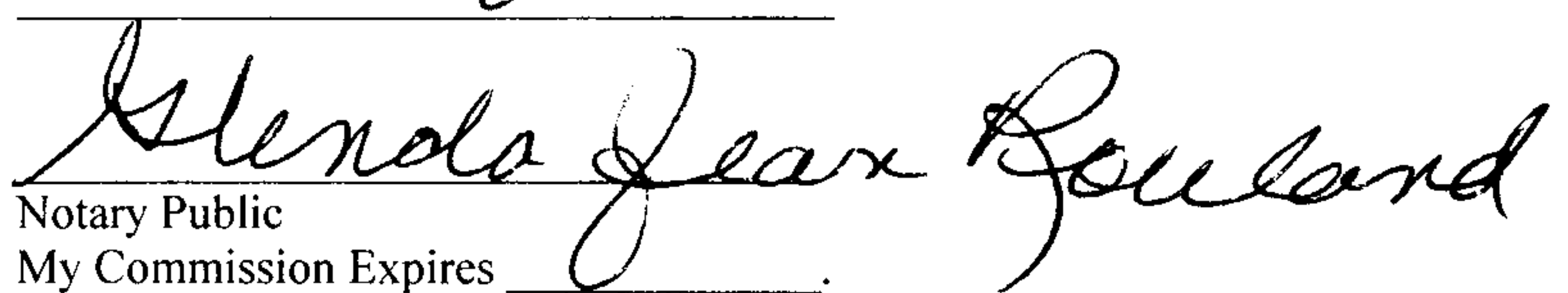
