The Association claims a lien upon property owned by **Peggy A. Braden**, situated in Shelby County, Alabama described as follows:

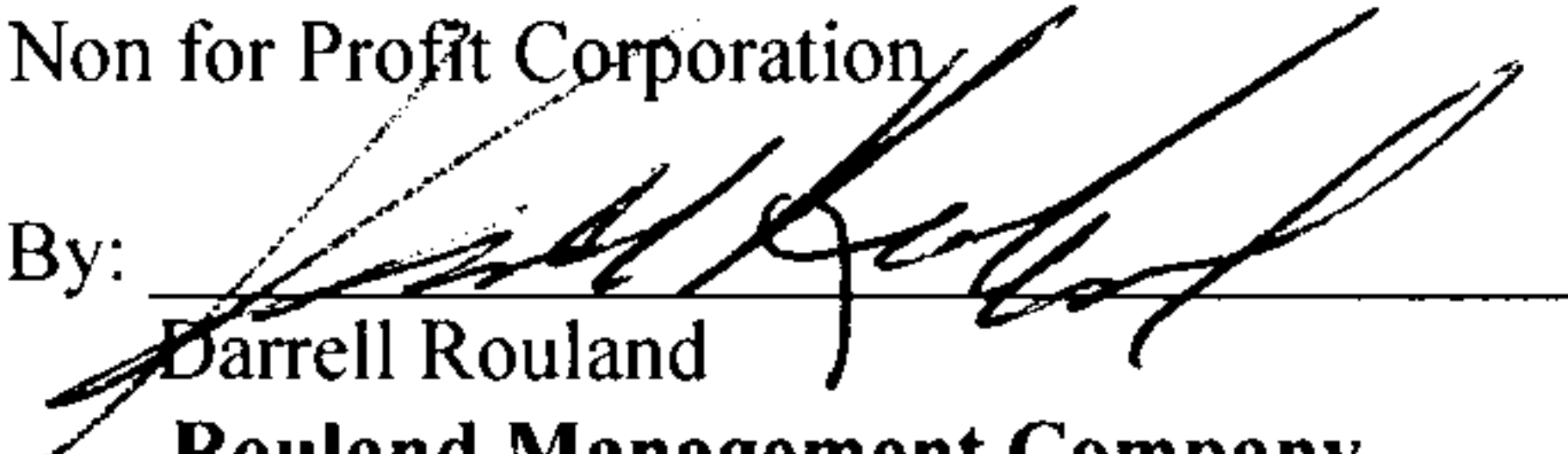

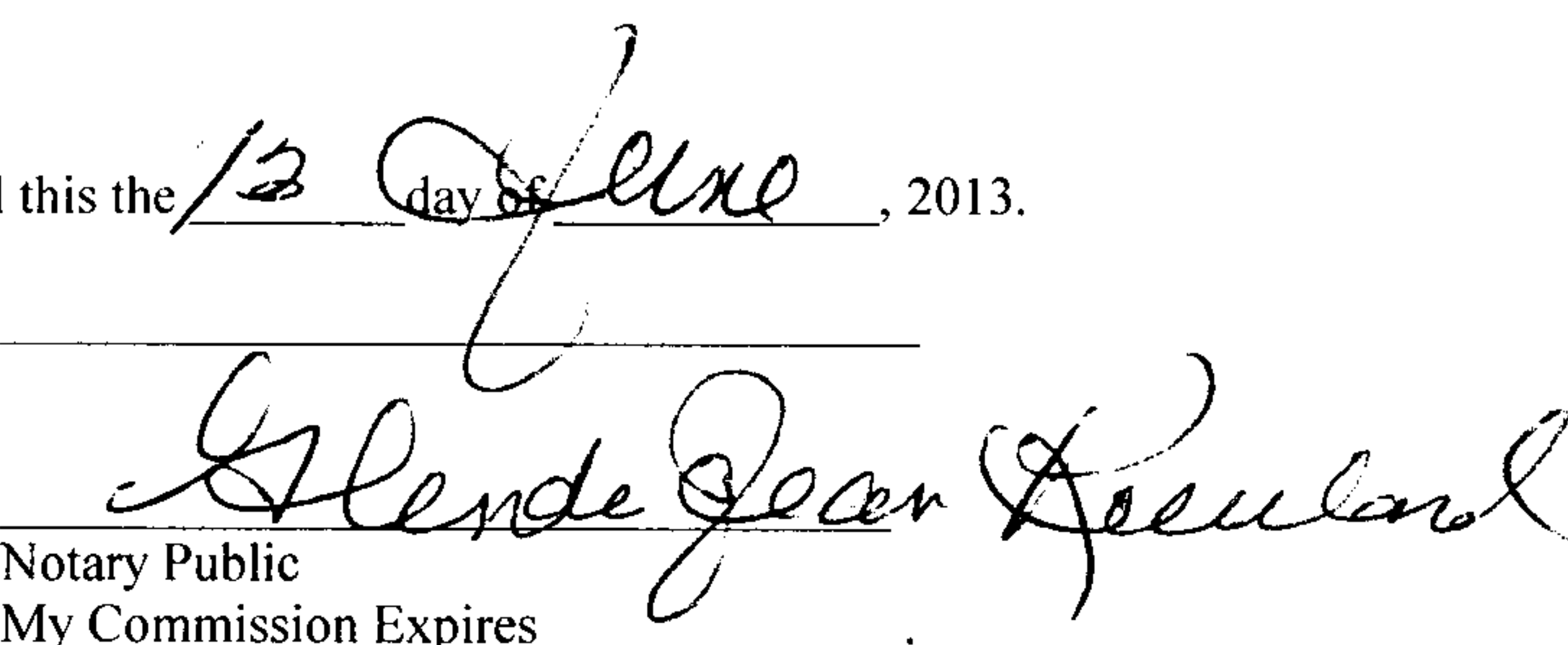
