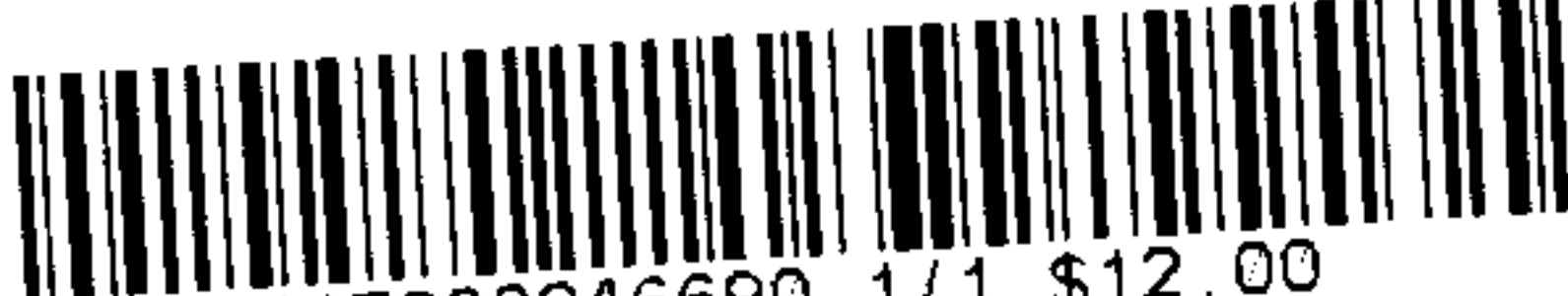

The Association claims a lien upon property owned by **Jean M. Bloodworth**, situated in Shelby County, Alabama described as follows:

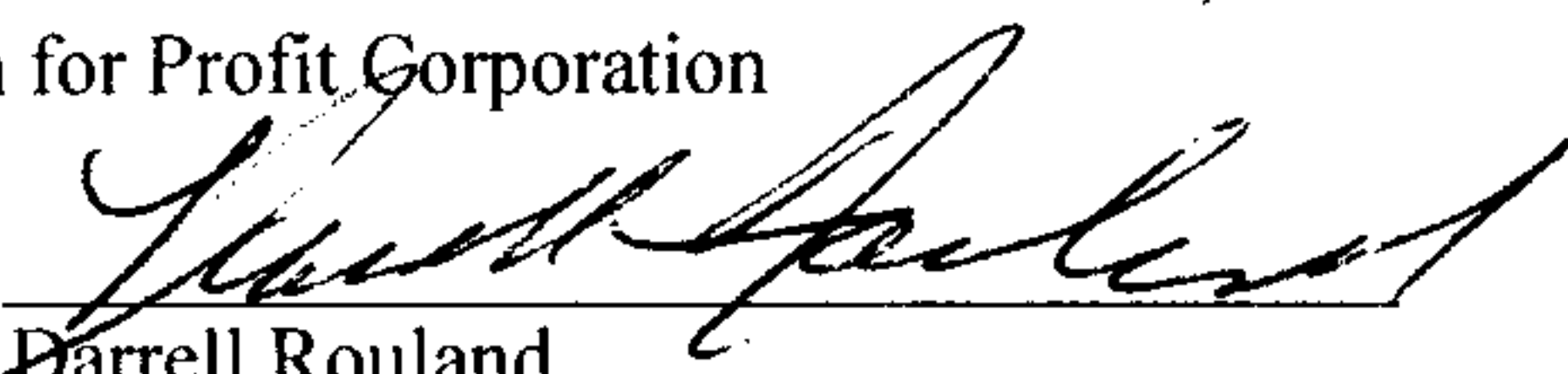
Lot 28, as recorded in Map Book 27, Page 11, Shelby County, Alabama records

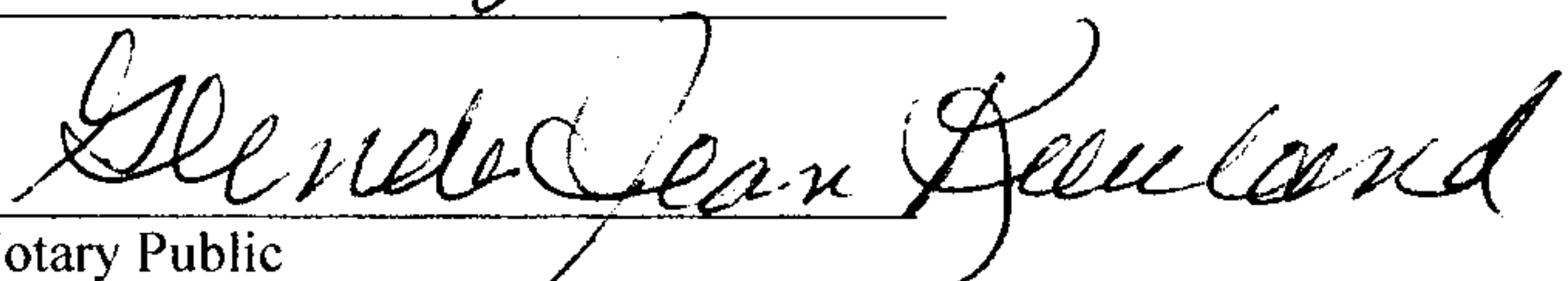
