FIRST AMENDMENT TO RIGHT-OF-WAY EASEMENT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, on October 19, 2004, United Land Corporation, corporate predecessor in title to Walter Minerals, Inc. (hereafter collectively referred to as "United Land"), as Grantor, executed a Right-of-Way and Easement Agreement (the "Right-of-Way Agreement") to GeoMet, Inc. ("GeoMet") as Grantee, said Right-of-Way Agreement recorded in the Shelby County, Alabama Office of Probate in Deed Book 2005, Page 0211000068500; and,

WHEREAS, it has come to the attention of United Land and GeoMet that said Right-of-Way Agreement has a typographical error in the provision that contemplates assignment of the Right-of-Way Agreement; and,

WHEREAS, it is the desire of the parties hereto that the Right-of-Way Agreement be amended to correct the typographical error.

NOW, THEREFORE, for and in consideration of the mutual benefits to be derived herefrom, United Land and GeoMet do hereby agree to amend the Right-of-Way Agreement dated October 19, 2004 as follows:

On page 3, in the 3rd paragraph, the sentence that reads "The rights of either party hereunder may be assigned or transferred in whole or in part" is deleted in its entirety and replaced with:

"The rights hereunder shall not be assigned by Grantee without the prior written consent of Grantor, which consent shall not be unreasonably withheld."

TO EFFECTUATE THE PURPOSES AND INTENT OF THE PARTIES HERETO, except as herein changed, all other terms and provisions of said Right-of-Way and Easement Agreement dated October 19, 2004 shall remain in full force and effect, and is hereby ratified, adopted and confirmed the same as if incorporated herein.

This Agreement is the entire understanding of the parties and there are no other agreements or understandings, written or oral, in effect between the parties related to the First Amendment of Right-of-Way and Easement Agreement described herein. This agreement may be amended or modified only by another writing duly signed and dated by both parties and such writing shall be appended to the end hereof.

IN WITNESS WHEREOF, this First Amendment of Right-of-Way and Easement Agreement may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all such counterparts together shall constitute for all


