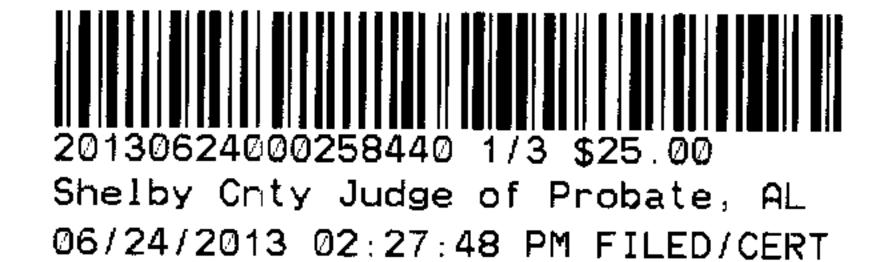
AUCTIONEER'S DEED

WHEREAS, Michael A. Wiygul and Susan Wiygul executed a mortgage to Mortgage Electronic Registration Systems, Inc.
