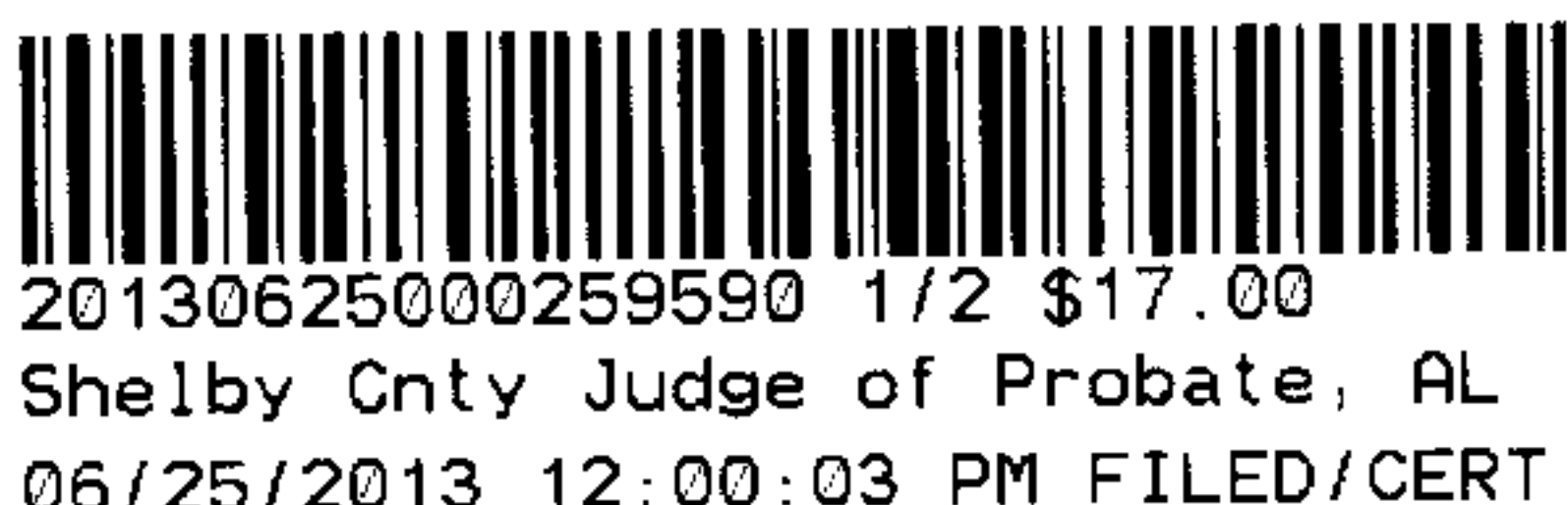

WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of Five Hundred and No/100 Dollars (\$500.00) AND FOR THE PURPOSE OF UPDATING THE VESTING NAMES to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, **Glen I. Jacobson and wife, Pamela E. Jacobson** (herein referred to as grantors) do grant, bargain, sell and convey unto **Glen I. Jacobson and Pamela E. Jacobson** (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

2. Restrictions, Easements and Right of Ways of record, if any.

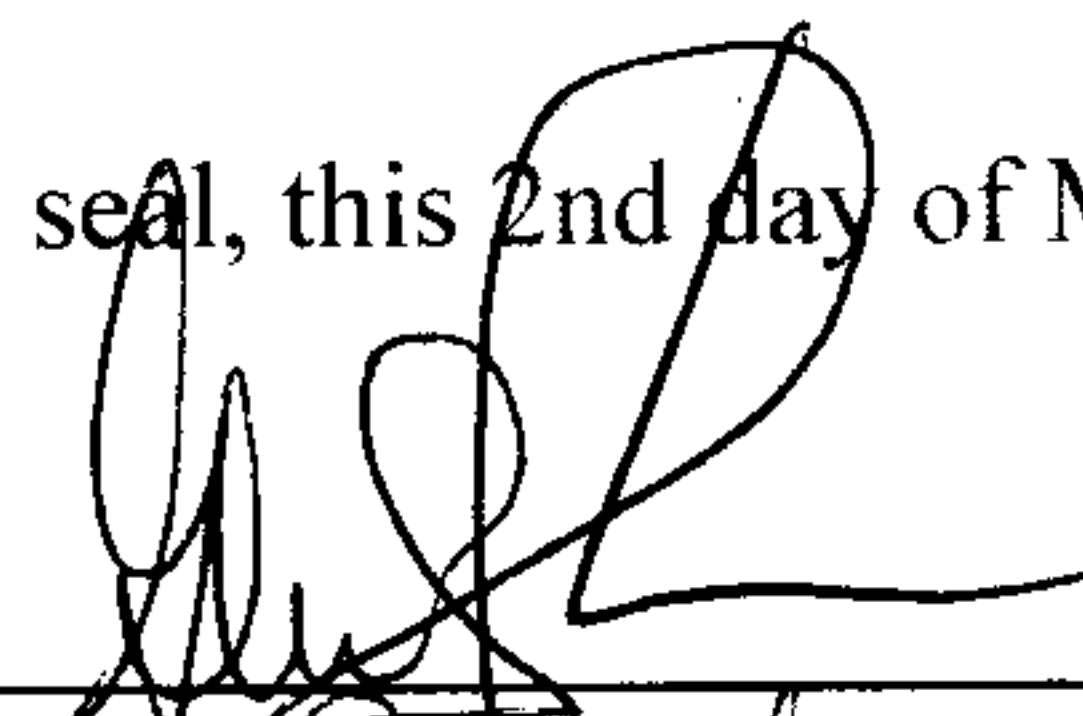

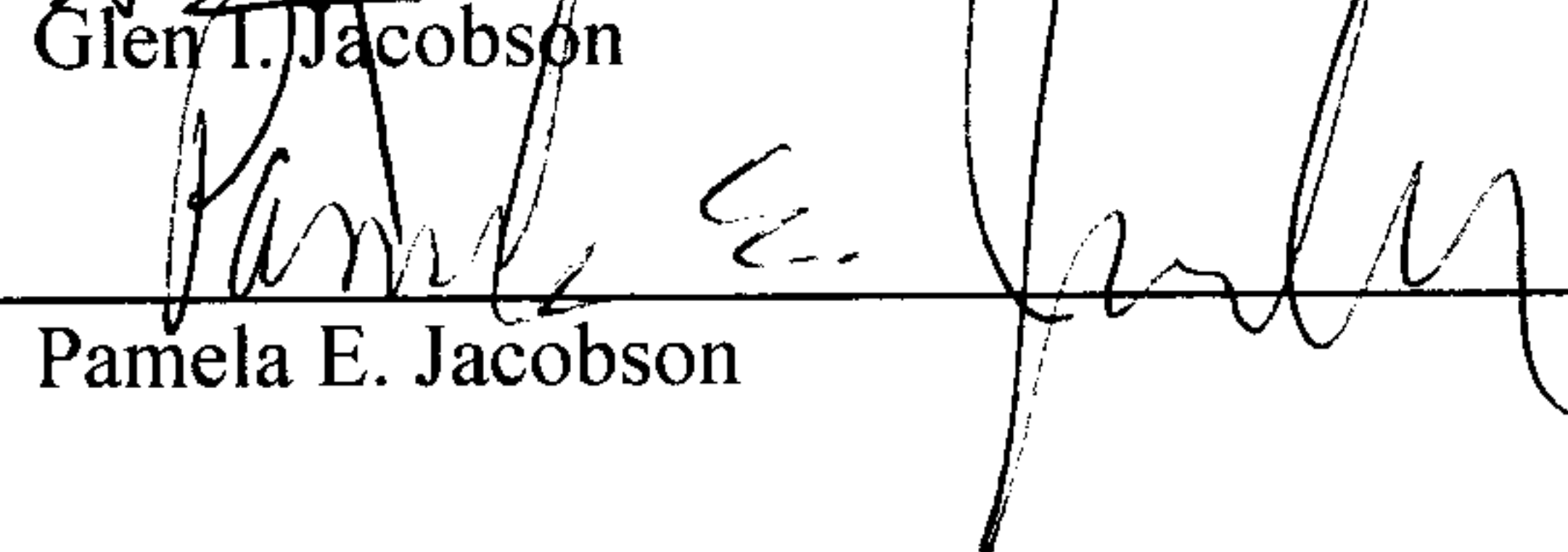
