

ARTICLES OF ORGANIZATION

Purposes

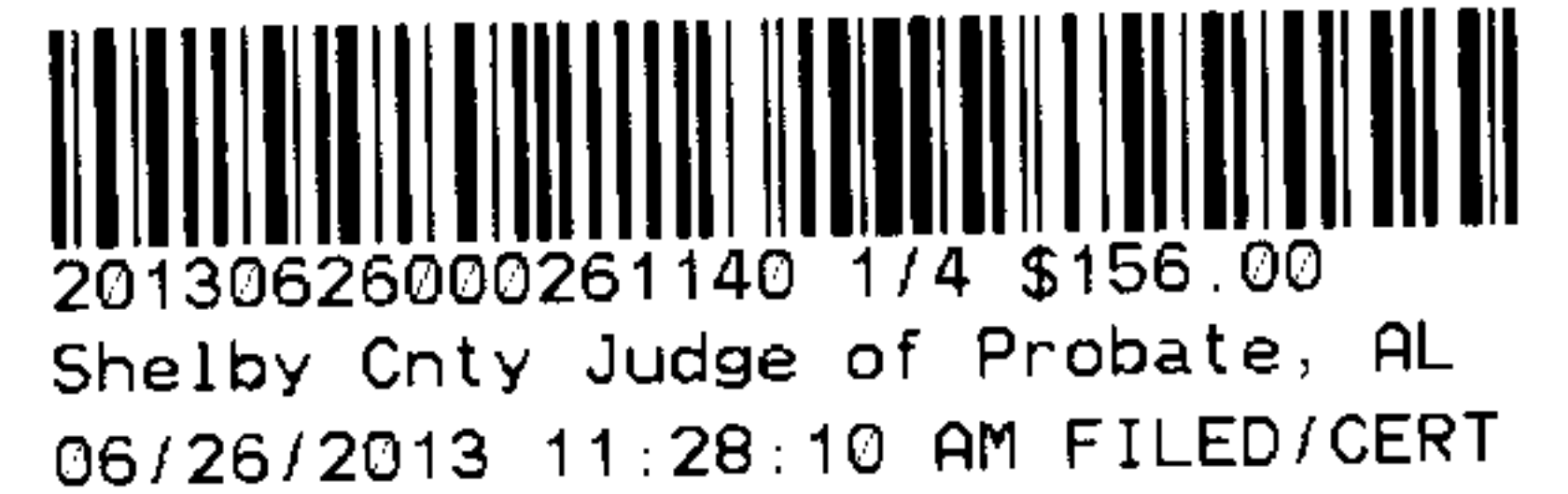
The purposes for which the Company is formed are:

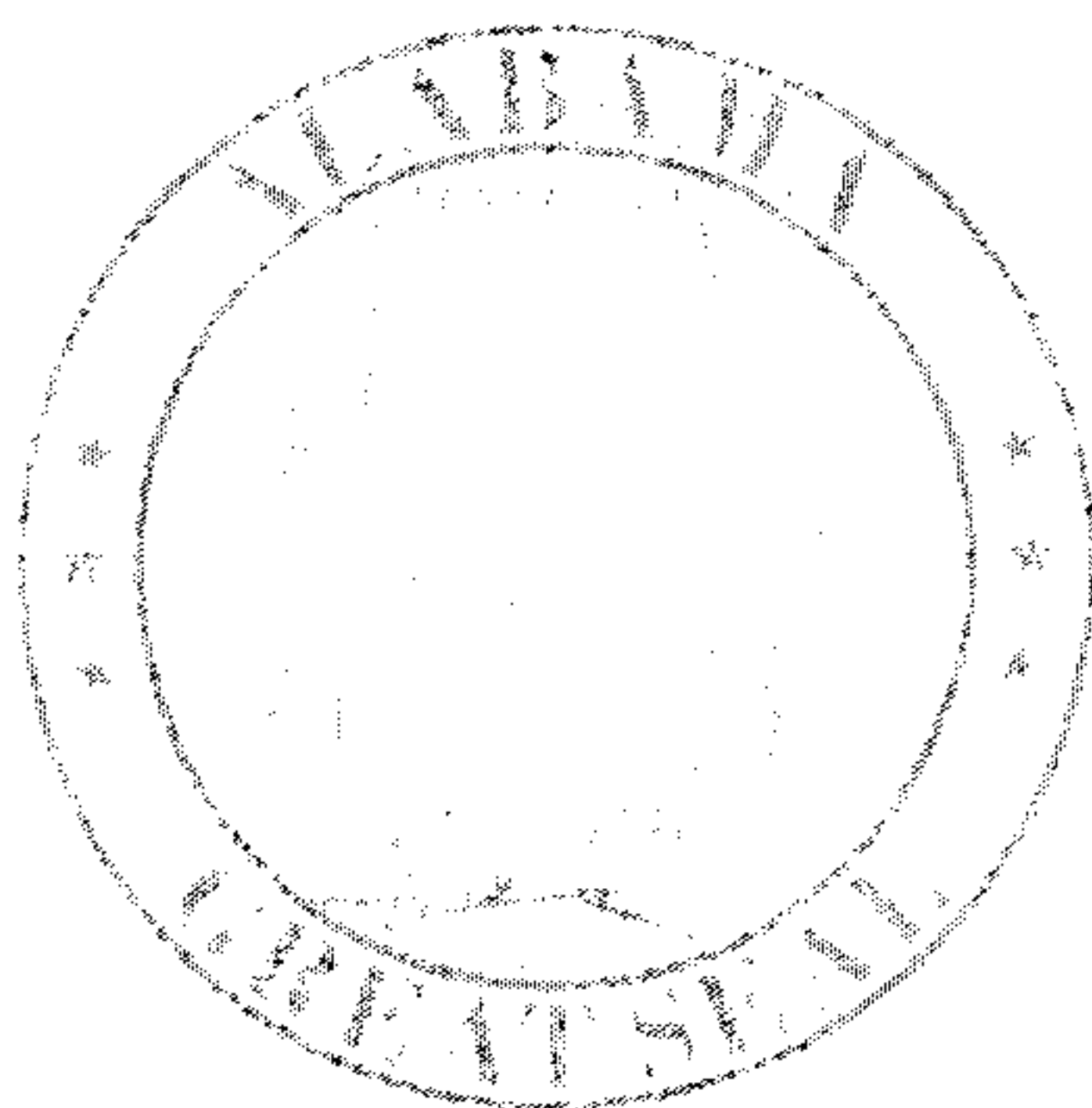
