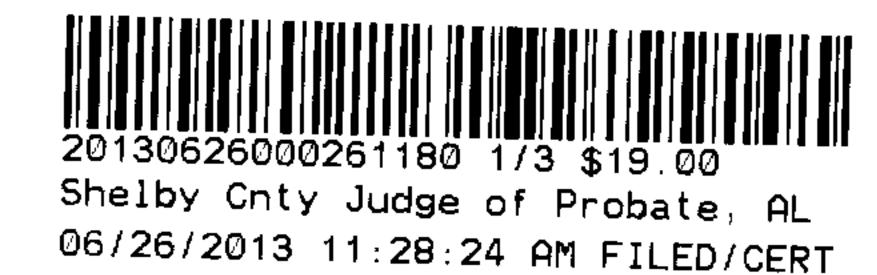

STATUTORY WARRANTY DEED



STATE OF ALABAMA COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One and no/100 Dollars (\$1.00) to the undersigned GRANTOR, the County Board of Education of Shelby County, Alabama, a statutory county board of education (herein referred to as GRANTOR), in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, and the exchange of like kind property of equal value, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Shelby County, Alabama (herein referred to as GRANTEE) in fee simple the following described real estate, situated in Shelby County, Alabama:

A parcel of land situated in the Southwest quarter of the Northeast quarter of Section 27, Township 21 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

Commence at a 1 inch crimp iron locally accepted to be the Southwest corner of the Southwest quarter of the Northeast quarter of Section 27, Township 21 South, Range 1 West, Shelby County, Alabama; thence run an assumed bearing of North 00 degrees, 12 minutes, 58 seconds East along the West line of said quarter-quarter Section for a distance of 558.75 feet to an iron pin set with a SSI cap; thence run South 88 degrees, 58 minutes, 19 seconds East for a distance of 1,061.04 feet to an iron pin set with a SSI cap at the point of beginning; thence run North 07 degrees, 48 minutes, 20 seconds West for a distance of 546.96 feet to a fence post; thence run North 88 degrees, 29 minutes, 23 seconds East for a distance of 345.46 feet to a PK nail set on the East line of said quarter-quarter Section; thence run South 00 degrees, 10 minutes, 23 seconds West along the East line of said quarter-quarter Section for a distance of 383.78 feet to an iron pin set with a SSI cap on the Northwest right of way line of Norfolk Southern Railroad; thence run South 56 degrees, 01 minutes, 25 seconds West along said Northwest right of way line for a distance of 299.91 feet to a ½ inch open top found; thence run North 88 degrees, 58 minutes, 08 seconds West for a distance of 21.20 feet to the point of beginning; said parcel containing 3.3844 acres, more or less.

Less and except all minerals and mineral rights previously reserved, and subject to all easements, conditions, exceptions, reservations, rights of way and encumbrances of record.

TO HAVE AND TO HOLD to the said GRANTEE and its successors and assigns forever.
