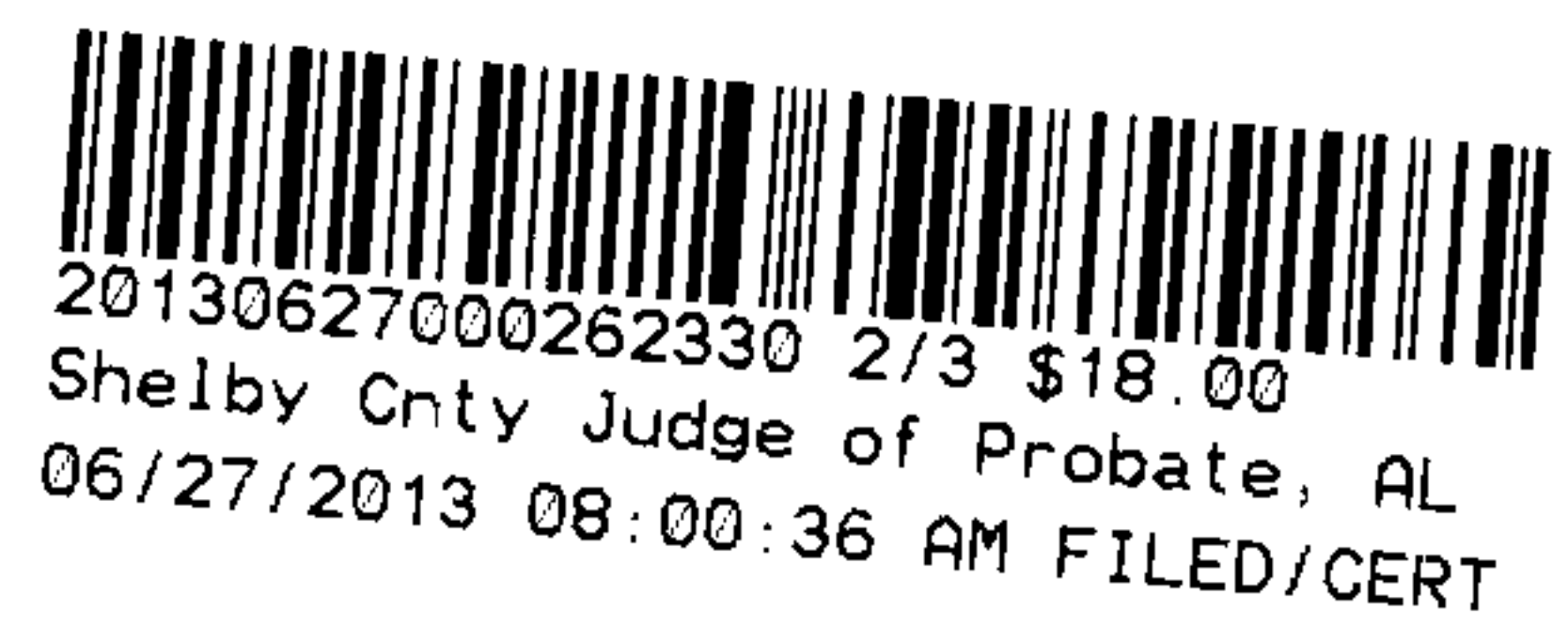
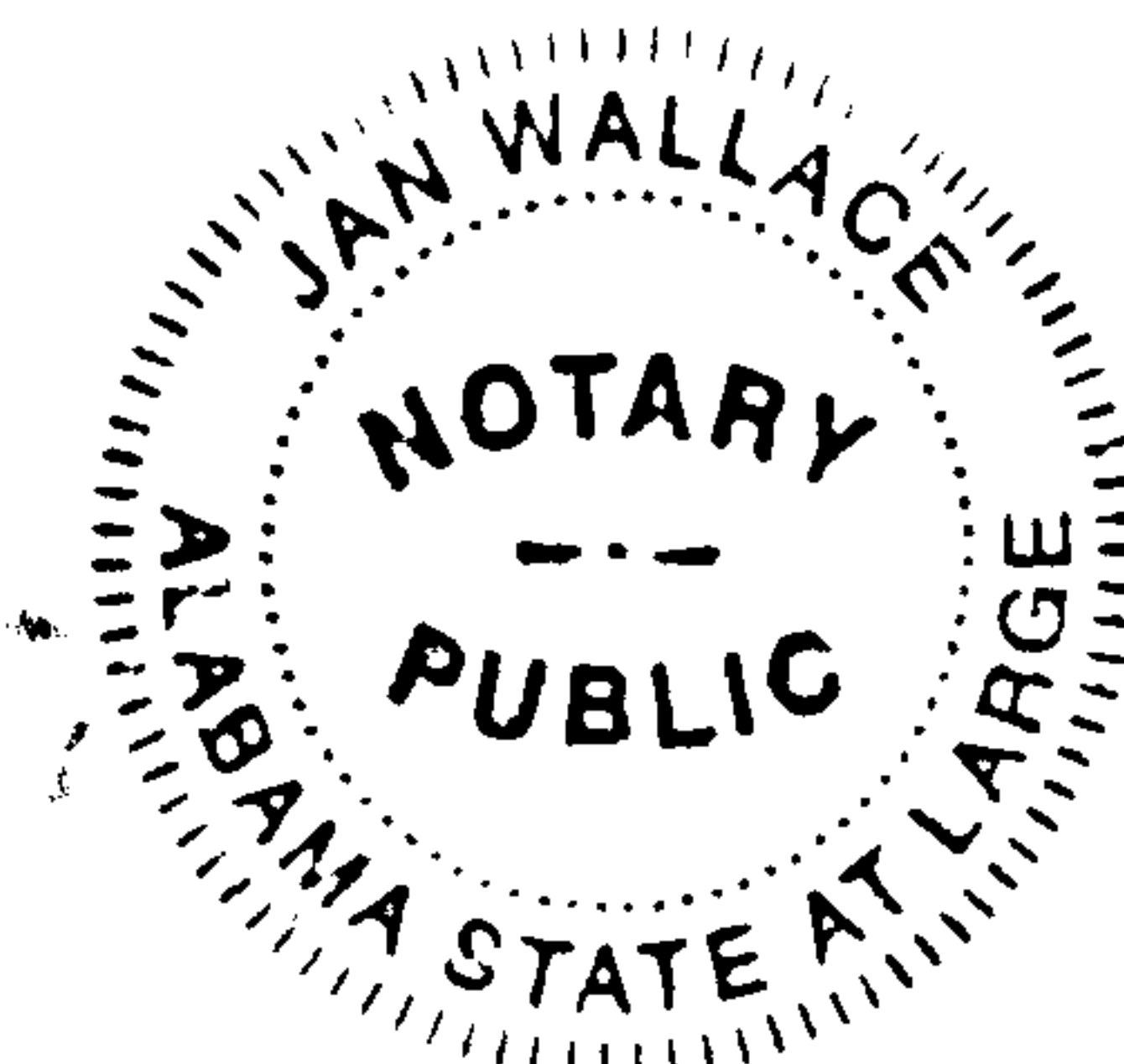


EXHIBIT A
