Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

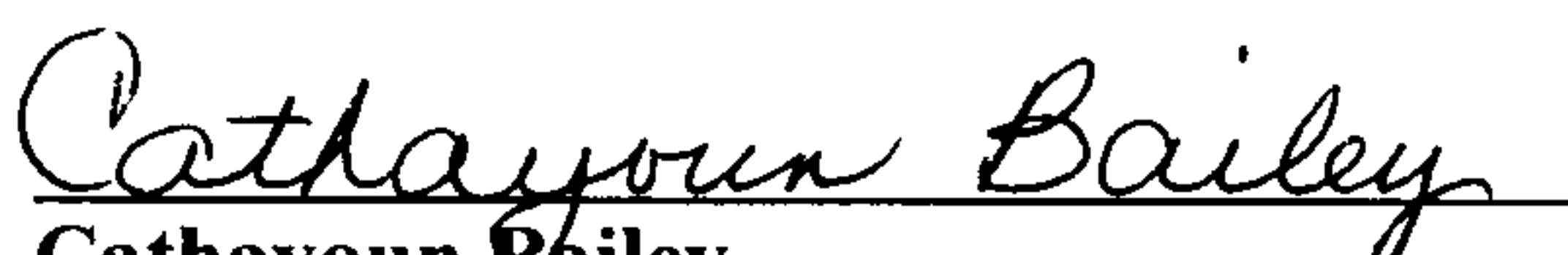

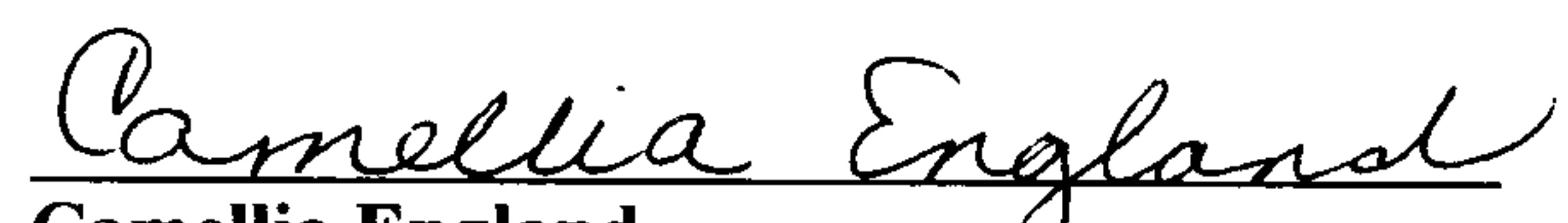
This property does not constitute the homestead of the grantor as defined in §6-10-3, Code of Alabama (1975).

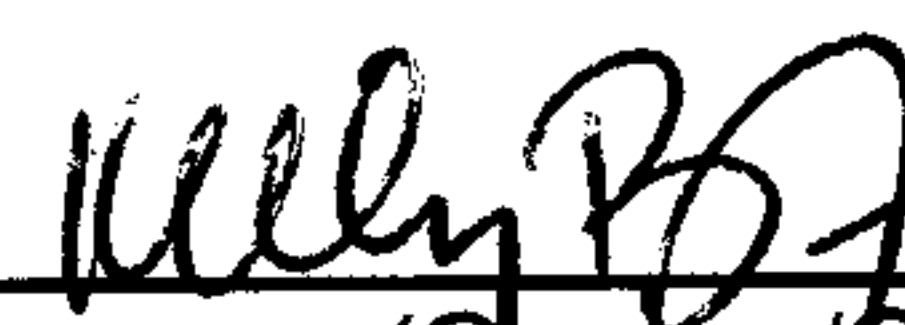
