## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **One Hundred Seventy-Four Thousand and 00/100 Dollars (\$174,000)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Randall Thomas Baker and Dorothy M. Baker**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 24, according to the Survey of Cedar Grove at Sterling Gate, Sector 2, Phase I, as recorded in Map Book 25, Page 52, Shelby County, Alabama Records.**



\$172,288 of the proceeds come from a mortgage recorded simultaneously herewith.
