## **Articles of Organization of** **Express Service Center LLC**

Pursuant to the Provisions of Sections 10-21-1 of the Code of Alabama (1975) as amended (the "Alabama Limited Liability Company Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

### **ARTICLE ONE**

The name of the company shall be Express Service Center LLC.

The period of duration shall be for a period of thirty-five (35) years, unless the Members agree to extend its duration or the Company is dissolved and its affairs wound in accordance with the Alabama Limited Liability Company Act.

### **ARTICLE FOUR**

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms of their admission shall be set forth in the Company's Operating Agreement.

### **ARTICLE SEVEN**


The Company may be reconstituted and the business of the Company may be continued following an event of dissociation which terminates the membership of a member of the
