SPECIFIC POWER OF ATTORNEY

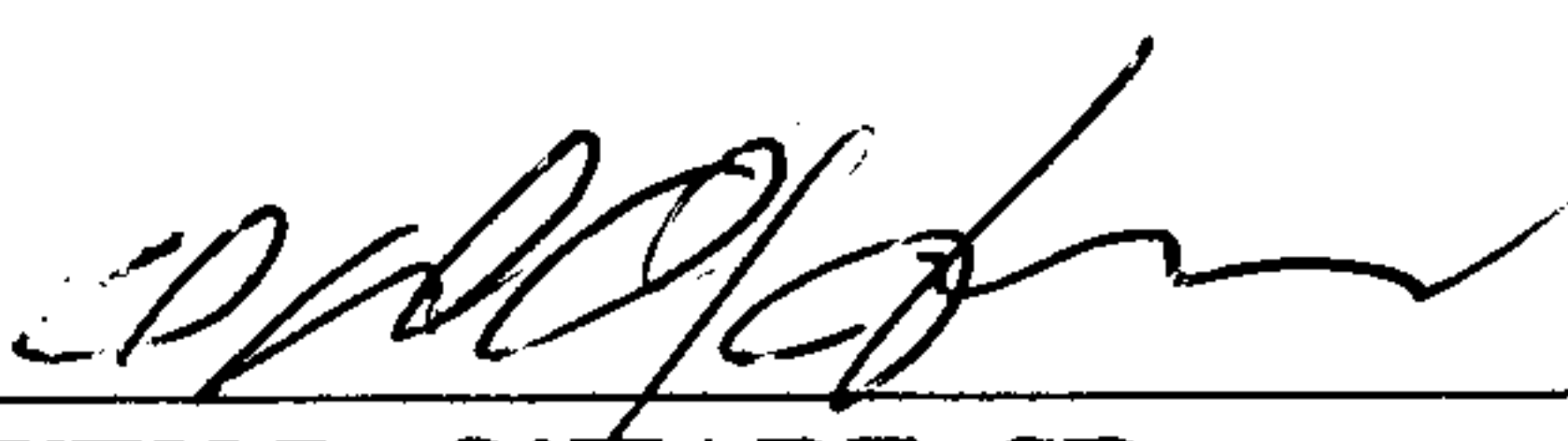

and effect as an original.

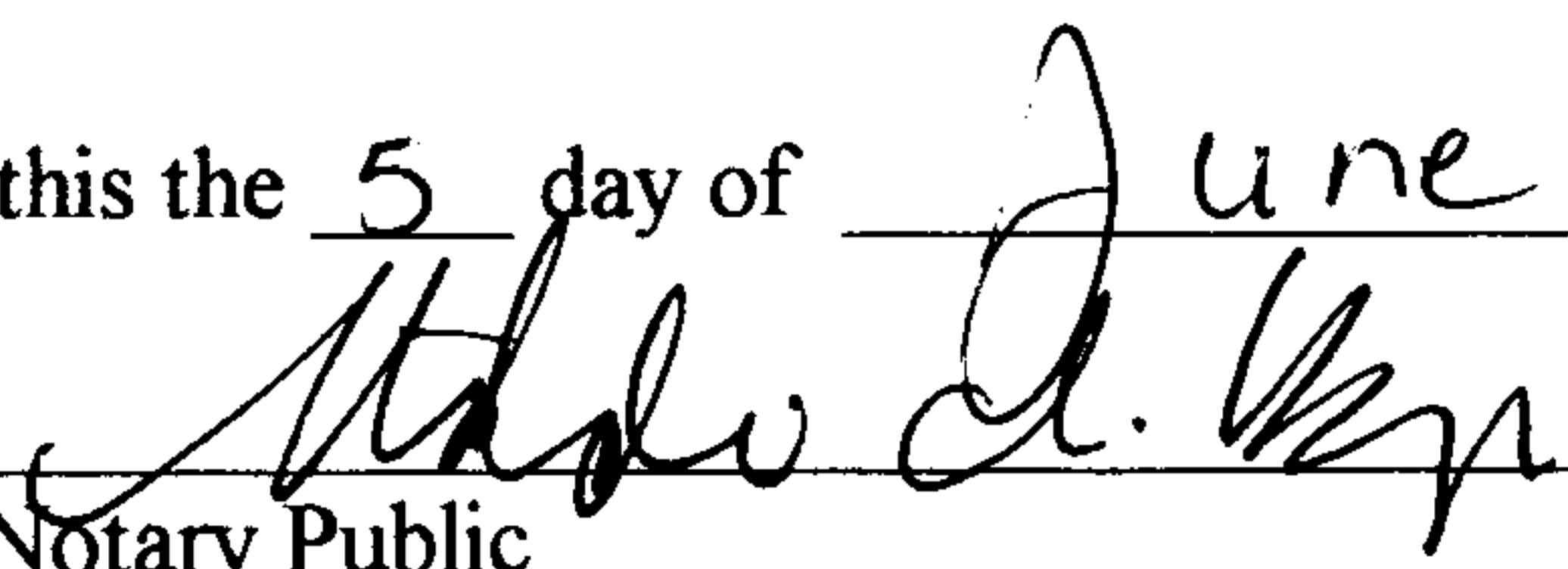
