
# ARTICLES OF ORGANIZATION OF MAIRAZ, LLC



The undersigned, acting as the organizer of an Alabama limited liability company pursuant to the Alabama Limited Liability Company Law (the "Act"), Alabama Code §§ 10A-5-1.01, et seq., (1975), hereby adopts the following Articles of Organization for MAIRAZ, LLC (the "Company").

# ARTICLE I

The name of the Company shall be MAIRAZ, LLC.

#### **ARTICLE II**

The purpose for which the Company is formed is to engage in the buying and selling of real estate, rental of real estate, and property management, and to engage in any other business or activity that now or hereafter may be necessary, incidental, proper, convenient, or advisable to accomplish those purposes (including, without limitation, obtaining financing therefor) and that is not forbidden by the laws of any jurisdiction in which the Company engages in such business.

#### ARTICLE III

The Company shall continue in existence until it is dissolved in accordance with the Act.

#### ARTICLE IV

# **ARTICLE VI**

## **ARTICLE VII**

The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be mutually agreed by the Company and the additional members.

## ARTICLE VIII

If an event of disassociation terminates the continued membership of a member in the Company, the business of the Company may nevertheless be continued if, within ninety (90) days after the occurrence of said event of disassociation, all of the remaining members of the Company consent to the continuance thereof and if there is at least one remaining member thereof.

#### **ARTICLE IX**

The Company shall be managed by its members.

#### ARTICLE X

The internal affairs of the Company shall be regulated and conducted subject to the requirements of these Articles and the Act.
