FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of March, 2010, Jana L. Wilson, a single person, executed that certain mortgage on real property hereinafter described to Homeservices Lending, LLC, Series A dba Homeservices Lending, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20100402000099410, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., successor by merger to Wells Fargo Home Mortgage, Inc. , by instrument recorded in Instrument Number 20100928000319330, in the aforesaid Probate Office ("Transferee"); and

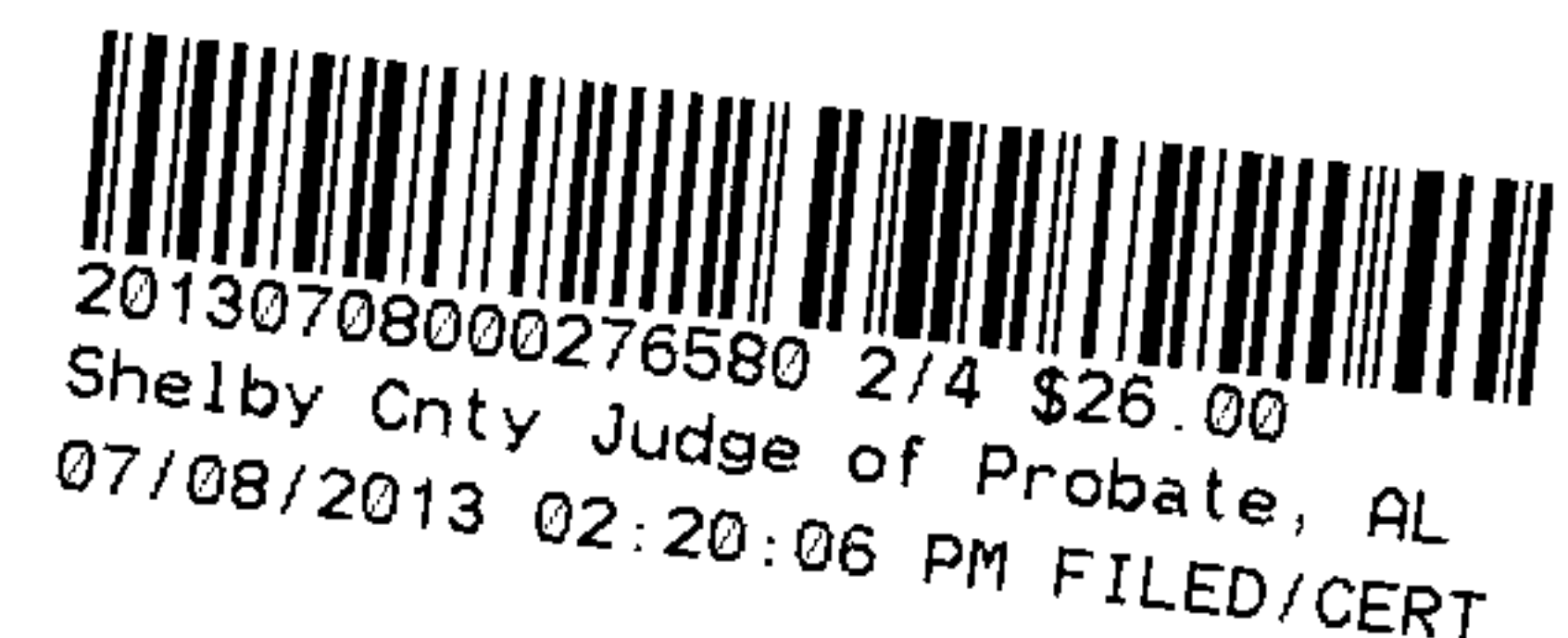

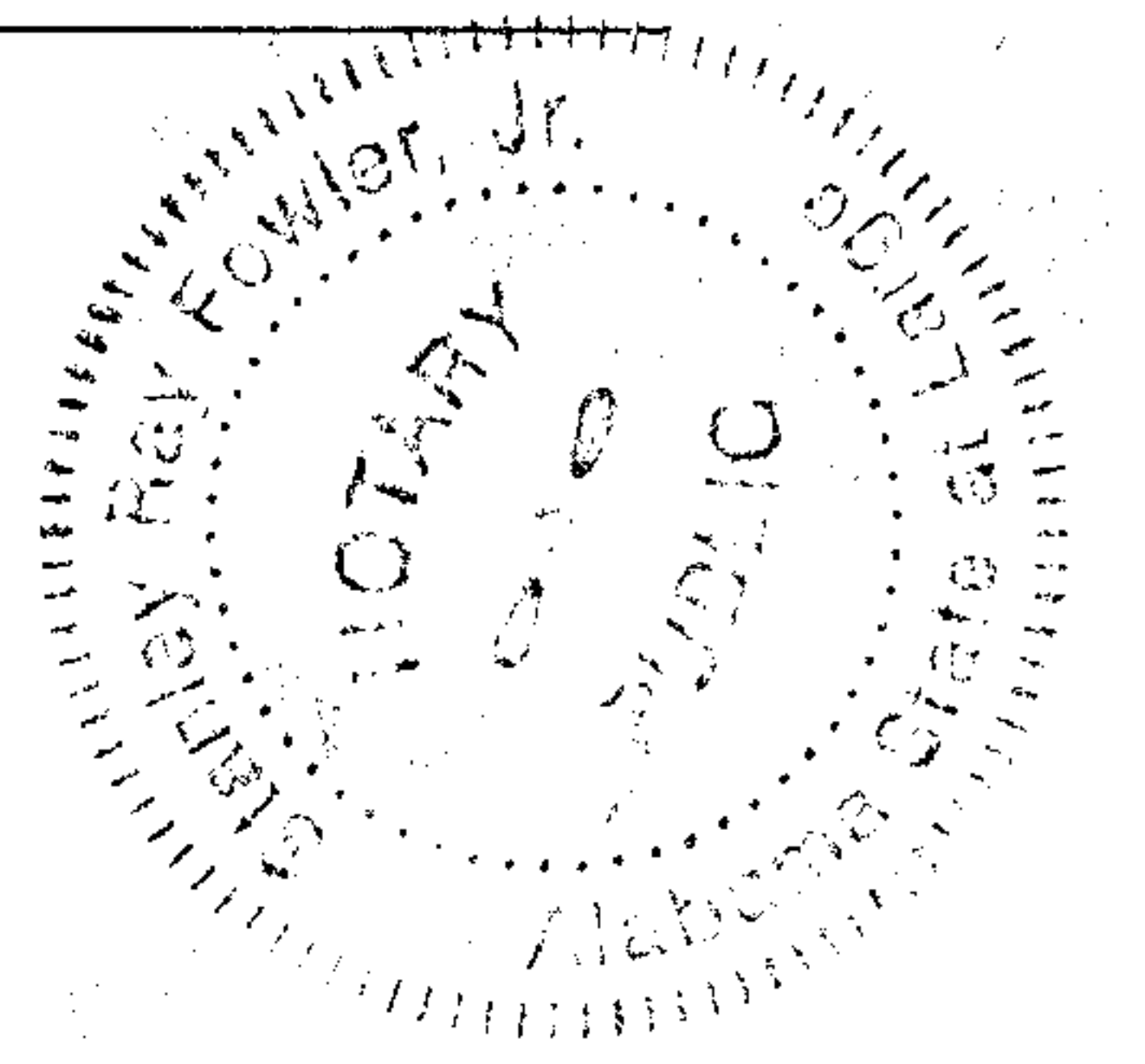
