Adairy Allen, Daughter, whose approximate age at the time of Jube Gilbert's death was Sixty-Two (62) and who is currently alive and of sound mind.

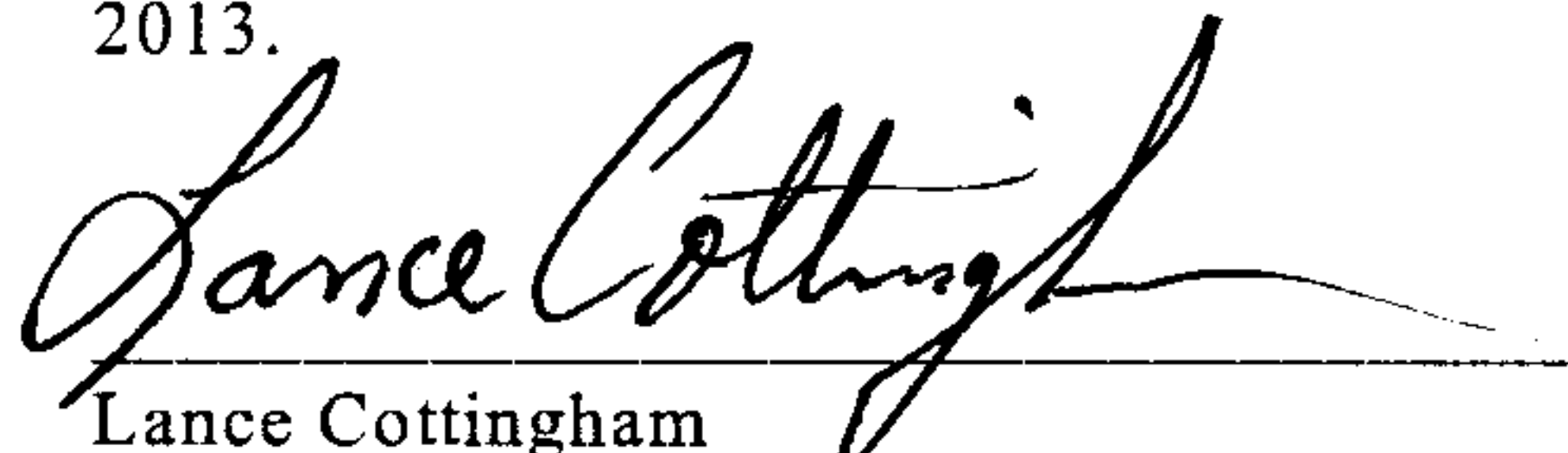
Audrey Butler, Daughter, whose approximate age at the time of Jube Gilbert's death was Sixty - Two (62) and who is currently alive and of sound mind.
