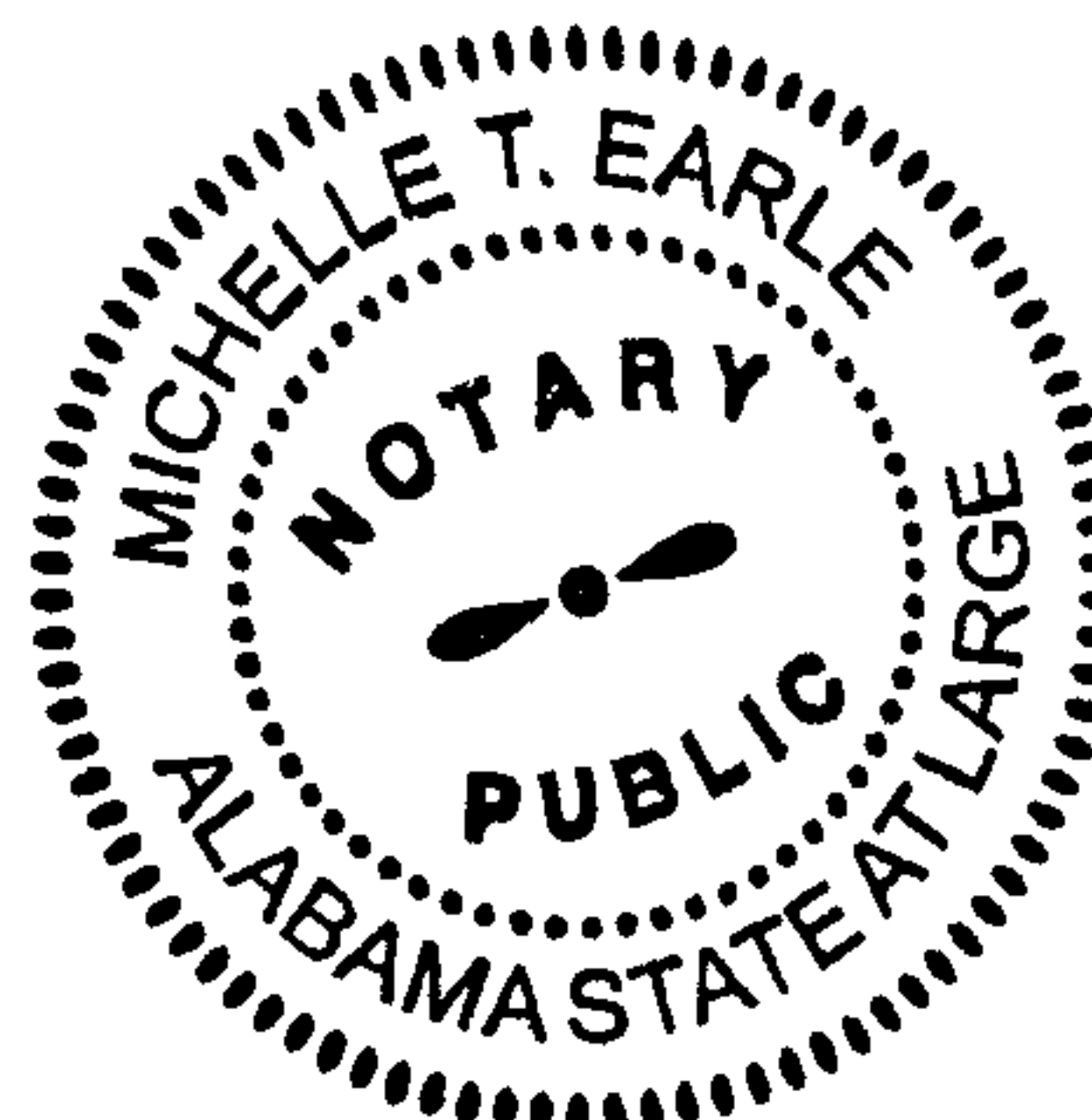

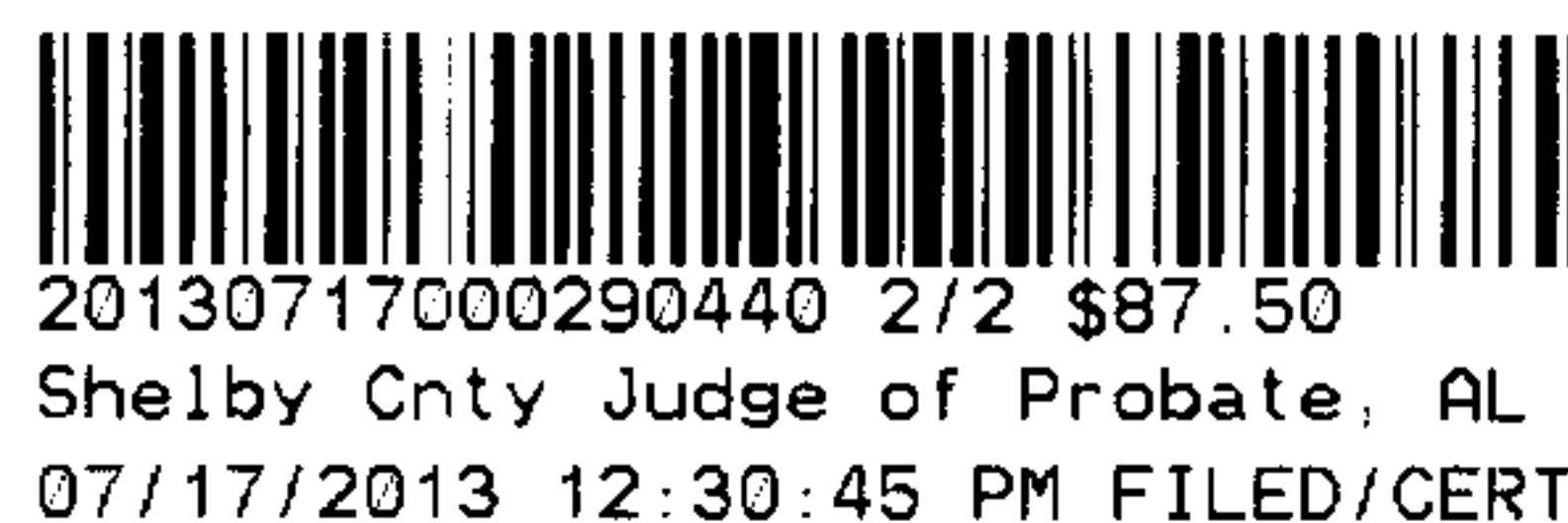
## Instructions
